In reference to the above cited subject, I would like to draw your kind attention towards holding of JTO(T) Limited Internal Competitive Exam under 50% Internal Quota for the vacancy years 2016-2017 and 2017-18 which may be notified as early as possible. Your kind direction in this regard will not only fulfil aspiration of qualified JEs but will also reflect firm determination of your good office in respect of regular process of career progression and motivation to the talented working youth. The notification for the both JTO(T) LICEs for the vacancy years 2016-17 and 2017-18 is already due w.e.f 01-07-2016 and 01-07-2017 respectively. But due to various administrative causes, delay has incurred in the process resulting in loss of opportunities of the legitimate candidates who may suffer this perpetual loss. We are entreating your good office to publish the notification for holding JTO(T) LICE under 50% internal quota for the vacancy year 2016-2017 and 2017-18 simultaneously as here lesser number of candidates are eligible for vacancy year 2016-17. We are overwhelmed by your administration, the way you successfully conducted three consecutive JTO (T) LICE for the vacancy year 2013-14, 2014-15 and 2015-16 in a single year 2016. Almost all aspiring candidates were promoted as Group B officers with maximum eight years of regular service. The three years loss of regular service (8-5=3 years) for qualification according to JTO (T) RR-2014 would have been compensated if there were regular yearly conduction of LICE for JTO(T).
