

JOINT FORUM OF BSNL EXECUTIVES' ASSOCIATIONS

A meeting with office bearers of Kerala Circle Body, AIGETOA was held in the presence of CHQ office bearers of AIGETOA and SNEA. From Kerala, Shri Saheer S. CS, AIGETOA, Shri Ansal Mohammed CH., CFS, AIGETOA, Shri Madhumohan H, DP Trivandrum SSA, Shri Maxmillan K, VP AIGETOA, Shri Vipal Prem, ACS AIGETOA, From AIGETOA CHQ, Shri Ravi Shil Verma, GS AIGETOA, Shri Amit Roy, JS (North), AIGETOA, Shri Vivek Kumar Singh, OS AIGETOA and From SNEA Side, Shri A.A. Khan President, Shri K. Sebastin, GS, Shri M.S. Adasul, Dy GS, Shri P. Padmanabha Rao, AGS, SNEA were present in the meeting. Finer points with respect to discussion in the office of PGM (Pers), BSNL CO on 25.05.2017 was discussed on the matter relating to the seniority cum Fitness Quota promotion from JTO (T) to SDE(T) cadre which is under legal dispute at Hon'ble High Court, Kerala. It was informed that following can be agreed by both the parties and the stalemate with respect to issuance of promotion orders in the cadre of JTO(T) to SDE(T) can be ended :

• promotion orders to SDE cadre for entire stakeholder JTO batches of different O.P. CATs at Hon. High Court of Kerala is done by management by filling up all the available vacancies which has arisen under 67% seniority cum fitness quota subject to the condition that the seniority fixation in JTO cadre which is under challenge (i.e. for 1:1) will be decided as per the outcome of the court cases at Hon'ble Highcourt, Kerala.

Management will initiate proceedings for executing the promotions and will approach Hon,ble High Court for permission for the same. An affidavit with regard to the discussion shall be furnished by both the parties through Hon'ble High Court Mediation as the matter is Sub-Judice.

It was decided that Joint Forum will pursue on these lines with management and ensure promotions at the earliest.
