## MASS RESOLUTION BY JTOs of 2K7 & 2K8 BATCH CHQ/CIRCLE/DISTRICT OFFICE BEARERS OF AIGETOA DURING MEETING HELD ON 05.08.2020

## **Dear Friends/Colleagues**

We the torch bearers of 2k7 & 2k8 Batch and the office bearers of AIGETOA, are working day and night for the resolution of grievances of our friends at every level since long. Friends, during these last 11 years, we have witnessed several incidences of harassment of our friends, like non consideration of genuine Rule-8/9 transfer cases, rural posting issues, settlement of EPF issues, settlement of dies-non cases, issuance of charge sheet for miniature issues, non-forwarding of NOC cases and etc-etc. Despite these day to day problems, our friends have done excellent work with full vigor and zeal throughout these 11 years for the betterment of BSNL and no-doubt we are the backbone of BSNL.

Friends, we have met with In-Justice at several occasions in BSNL, but the most demoralizing is the loss of pay due to fixation of pay at 19020/- initial basic when we were recruited on 9850/- pre-revised basic and this needs to be fixed at 22820. AIGETOA CHQ is putting its best efforts since long for the settlement of 22820/- issue through several Strikes/Dharnas/protests and as per the commitment during 1st MVunder the banner of United forum, we were succeeded in formation of PANDA Committee to address the Payloss issue i.e. 22820/- of 2k7 Batch JTO, 2k8 Batch JTO and 2k10 Batch JAO. But due to the demand of then Majority Association i.e. to extend the 22820/- to all batches recruited after 2k7 as well as to those who are going to be recruited by BSNL in coming days, the issue of 22820/- got derailed as it let to increasing in expenditure of BSNL to the tune of 800 crs.

Friends, after that, AIGETOA CHQ had done several discussions with management every now and then, and management every time took shade by saying that this demand is already lost in CAT. Hence AIGETOA CHQ didn't wait at all and after a threadbare analysis of OA, lost case of Sh.Shailendra Singh, was successfully reopened in PCAT Delhi in October 2018 for 22820/-. In this Pay Parity case, respondent reply has already been received, the first judicial hearing was scheduled to be held on 14/04/2020 but that was posponed due to Covid-19. We are hopeful as soon as court opens, we will be in position to get our case heard asap and we are very much hopeful of concluding the case in our favour with the persistent efforts of 2k7 & 2k8 AIGETOA CHQ Team. The applicants are AIGETOA CHQ/Circle office Bearers of 2k7 &2k8 Batch and the main applicant who is seeing the day to day progress is Sh.Vivek Kumar Singh,OS AIGETOA CHQ, a JTO from 2k7 Batch.

Friends, we have witnessed the betrayal of majority association in June 2018 when JTO to SDE promotion orders were issued violating clear cut judgment of 1:1(DR:PR) criteria of Ernakulam CAT .After that by the efforts of AIGETOA CHQ ,Mgmt has called for gradation list & SCR data till YOR 2008 .Our many 2k7n8 OBs have done marathon work with circle&district AIGETOA leaders in collecting all the data with pers section till Dec 2018. But again Majority association had its true colors by filing the review petition on the basis of confusion

astra. The worst part is that even without having stay on DPC, Our majority Association/Management have not made any effort till date to conduct the DPC. Friends, we are very close of getting DPC done and the team under the leadership of Sh.Yogender Kumar AGS AIGETOA CHQ, JTO 2k8 Batch is monitoring the day to day progress of case.

Friends, we 2k7 & 2k8 Batch JTOs have a good representation in District/Circle/CHQ level and are contributing our best for the resolution of issues of our people in field. Friends, after VRS, it's a golden opportunity for all of us to make AIGETOA a Majority Association and without your vote it cannot be possible. Friends, We are not in hundreds but in thousands, representing 2k7 & 2k8 issues at AIGETOA platform, even our Office Bearers of 2k7 & 2k8 Batch in AIGETOA are in hundreds, so it is a humble request to vote for none other than your own group of 2k7 & 2k8 Sufferers who will get your issues settled through AIGETOA platform.

WE, 2k7 & 2k8 Batch AIGETOANs have passed these resolutions unanimously in meeting held on 05.08.2020:-

- 1. To complete the JTO-SDE DPC at the earliest.
- 2. To settle the 22820/Payloss issue of 2k7 batch JTO,2k8 batch JTO and JAOs of 2k10 batch within six month of time.
