Subject:- Removal of disparity in Pay of DR JTOs of Recruitment year 2005.

A proposal for removal of disparity in the pay of Junior Telecom. Officers (JTOs) of 2005 Batch who joined before 01.01.2007 and those who joined after 01.01.2007 on revision of IDA pay scales of Board level and below Board level Executives w.e.f. 01.01.2007 has been considered by the Board of Directors of BSNL.

- 2. The Board has approved the proposal that the pay of all the JTOs of 2005 batch who joined after 01.01.2007 may be fixed at Rs.21620/- on date of joining the post of JTO as a special case in order to remove the disparity of pay between those JTOs of 2005 Batch who joined before 01.01.2007 and those who joined after 01.01.2007. So, the pay of the JTOs of 2005 Batch, who joined after 01.01.2007, may be fixed at Rs.21620/- from the date of their joining in the post of JTO. It has been further decided that this special dispensation will not be extended to JTOs of subsequent years.
- 3. The other terms and conditions as contained in this office order No.1-50/2008-PAT(BSNL) dated 5.3.2009 regarding revision of scales of pay w.e.f. 01.01.2007 for Board level and below Board level executives of BSNL will continue to be applicable to all the JTOs of 2005 batch.
- 4. Errors and omissions occurred while calculating the arrears therein are subject to rectification and correction. Overpayments made, if any, shall be recovered as per rules.
