

Recruitment Rules of Assistant (Accounts)/Junior Accountant/Senior Accountant Issue No.1

New Delhi,

26th June, 2002/Megha,

1. Short title and commencement:

- (1) With the approval of BSNL Board, the following rules regulating the method of recruitment t the posts of Assistant(Accounts)/Junior Accountant/Senior Accountant hereby made, namely,
- (2) These rules may be called the Assistant (Accounts)/Junior Accountant/Senior Accounta Recruitment Rules, 2002.
- (3) They shall come into force on the date of their issue by the Company.

2.Definitions: In these rules, unless the context otherwise requires:

- Company: Means the Bharat Sanchar Nigam Limited (A Govt. of India Enterprise) having its registered office at Sanchar Bhavan, New Delhi. (i)
- Board: Means the Board of Directors of the Company and includes in relation to the exercise of powers any Committee of the Board/Management or any Officer (ii) of the Undertaking to whom the Board delegates any of its power.
- Appointing Authority: Circle IFA is the appointing authority to the grade of Assistant (Accounts)/Junior Accountant/Senior Accountant. (iii)
- Assistant (Accounts)/Junior Accountant Internal Examination means the (iv) examination referred to in the Schedule.

- Examination means an examination held in accordance with the rules. (V)
- Assistant (Accounts) was earlier called Lower Division Clerk (Telecom Accounts) in the (vi) Department of Telecommunications
- 3. Application: These rules shall apply to the posts as specified in column (1) of schedule annexed to the Rules.

4. Number of Posts, classification and scale of pay: The number of posts in the grade of Assistant (Accounts)/Junior Accountant/Senior Accountant, its classification and the scale of pay attached thereto shall be as specified in columns 2 to 4 of Schedule annexed to these rules.

5. Method of recruitment, age limit, qualifications etc.: The method of recruitment, age limit, qualifications and other matters relating to the said posts shall be as specified in column 5 to 13 of the said schedule.

6. Disqualification: -No person-

- (a) Who has entered into or contracted a marriage with a person having a spouse living,
- (b) Who having a spouse living, has entered into or contracted marriage with any person,

Shall be eligible for appointment to the said post;

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

7. Bond and Training:

- All candidates recruited against the vacancies for direct recruitment shall execute a Bond in the format as specified by the Company to serve in BSNL for a period of five years (i): from the date of their appointment as Assistants (Accounts)/Junior Accountant/Senior Accountant, in the proforma as prescribed by the Company.
- The candidates selected both against the direct recruitment quota of vacancies and departmental promotion quota of vacancies shall have to successfully undergo training as per the training plan laid down by the Company before their appointment as Assistant (ii) (Accounts)/Junior Accountant
 - the period of training, the direct recruit Assistant (Accounts)/Junior Accountant will be entitled to stipend (training allowance) as decided by the BSNL from time to time. (iii) 3.



- 8. - 9. Sphere of Duty: After the notification of recruitment rules, cadre of Assistant (Accounts)/Junior Accountant/Senior Accountant will be "Circle cadre".
- 10. Saving: Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, Scheduled Tribes, Other Backward concessions required to be provided for the Scheduled Castes, Scheduled Tribes, Other Backward Classes, Ex.Servicemen, and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
- 11. Initial Consitution of the Cadre: The following persons shall be members of the Cadre with effect from the date indicated against them.
- (i) All officials holding the posts of LDC (TA)/Junior Accountant/Senior Accountant on regular basis or have been selected for the post of LDC (TA/Junior Accountant/Senior Accountant but not appointed in the erstwhile DOT/DTS/DTO before commencement of these rules and those who have been absorbed in Bharat Sanchar Nigam Limited shall be deemed to have been appointed as have been absorbed in Bharat Sanchar Nigam Limited shall be deemed to have been appointed as have been absorbed in Bharat Sanchar Nigam Limited shall be deemed to have been appointed as
- (ii) The continuous regular service of officials referred to in sub-rule 11 (i) above before the commencement of these rules shall count for the purpose of probation, qualifying service for promotion, confirmation, seniority and pension.
- 12. Unfilled internal vacancies: In case the vacancies for a particular year earmarked for internal candidates remain unfilled, the unfilled vacancies will be filled up in the subsequent year by direct recruitment or vice versa.
