

Recruitment Rules of Junior Telecom Officers(Civil)

Issue No.: 1

New Delhi, Friday, August 14, 2001/Sravan 23, 1923 Saka

- 1. Short title and commencement:
 - i) With the approval of BSNL Board the following rules regulating the method of recruitment to the post of Junior Telecom Officer (Civil) in BSNL are hereby made, namely:
 - ii) These rules may be called the Junior Telecom Officer (Civil) Recruitment Rules, 2001 (Issue:I).
 - iii) They shall come into force with effect from 14 August 2001.
- 2.. Definition: In these rules unless the context otherwise requires,
 - 1) Company: Means the Bharat Sanchar Nigam Limited (A Govt. of India Enterprise) having its Registered Office at Sanchar Bhavan, New Delhi.
 - 2. Board: Means the Board of Directors of the Company and includes in relation to the exercise of powers any Committee of the Board/Management or any Unicer of the Undertaking to whom the Board delegates any of its powers.
- 3. Application: These Rules shall apply to the posts as specified in Colonia (1) of the Schedule annexed to these Rules.

Number of posts, classification and scale of pay: - The number of the said post, its classification and the scale of pay attached thereto shall be as specified in columns 2 to 4 of the Schedule annexed to these rules.

Method of recruitment, age limit, qualifications etc: — The memod of recruitment, age limit, qualifications and other matters relating to the said post shall be as specified in columns 5 to 11 of the said Schedule.

6. Disqualification: - No person, -

(a) Who has entered into or contracted a marriage with a person having a spouse living; or

(b) Who, having a spouse living, has entered into or contracted marriage with any person, shall be eligible for appointment to the said post.

7. Bond, training and Syllabus :-

(1) All candidates recruited against the vacancies for direct recruitment shall execute a bond in the format as specified by the company to serve in BSNL for a period of five years from the date of their appointment as Junior Telecom Officer (Civil), in the proforma as prescribed by the Company.

(2) The candidates selected both against the direct recruitment quota of vacancies and departmental promotion quota of vacancies shall have to successfully undergo training as per the training plan laid down by the Company before their appointment as Junior Telecom Officer (Civil).

- 8. Service under the Territorial Army: A Junior Telecom Officer (Civil) who has not completed the age of forty years shall if so required, will be liable to serve in the Territorial Army subject to the provisions of section 6 A of the Territorial Army Act, 1948 (58 of 1948) and the rules made there under.
- 9. Saving.:- Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, Other Backward classes, Ex-servicemen and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.

10. Initial constitution-

- (i) All officials holding the posts of Junior Engineers (Civil) on regular basis in the Grammo DOT/DTS/DTO before commencement of these rules and those who have been absorbed in Bharat Sanchar Nigam Limited shall be deemed to have been appointed as Junior Telecom Officer (Civil) in BSNL.
- (ii) The continuous regular service of officials referred to in sub-rule 10(r) above before the commencement of these rules shall count for the purpose of probation, qualifying service for promotion, confirmation and pension.
