RECRUITMENT RULES OF "RAJBHASHA ADHIKARI" OF BSNL

F.No.22-35/2001-Pers.II

Dated the 5th August, 2005 at New Delhi - 110 001.

- Short title and commencement:-
 - In supersession of the Assistant Director (Official Language) i) Recruitment Rules, 2002 (Issue No.6), the Bharat Sanchar Nigam Limited Board approves the following revised Recruitment Rules.
 - These rules may be called Rajbhasha Adhikari Recruitment Rules, ii)
 - They shall come into force with immediate effect. iii)
- Definition:- In these rules, unless the context otherwise requires, 2
 - Company means Bharat Sanchar Nigam Limited (A Government of i) India Enterprise) having its Registered Office and Corporate Office at Statesman House, B-148, Barakhamba Road, New Delhi.
 - Board means the Board of Directors of the Company and includes in ii) relation to the exercise of powers any Committee of the Board/Management or any Officer of the Undertaking to whom the Board delegates any of its powers.
- Application:- These rules apply to the post specified in Column (1) of the Schedule annexed to these rules.
- Number of Post, classification and scale of pay:- The number of the said post, its classification and the scale of pay attached thereto shall be as specified in column 2 to 4 of Schedule annexed to these rules.
- Method of Recruitment, age limit, qualifications etc:- The method of recruitment, age limit, qualification and other matters relating to the said post shall be as specified in columns 5 to 13 of the said Schedule.
- 6 Disqualification:- No person,
 - a) Who has entered into or contracted a marriage with a person having

mirely

b) Who having a spouse living, has entered into or contracted marriage with any person, shall be eligible for appointment to the said post.

Provided that the competent authority may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this Rule.

- 7 Service under the Territorial Army:- Rajbhasha Adhikhari who has not completed the ace of 40 years if so required, will be liable to serve in the Territorial Army subject to the provisions of Section 6A of the Territorial Army Act 1948 (58 of 1948) and the rules made thereafter.
- 8. Bond and Training: All candidates recruited by mode of direct recruitment shall execute a Bond in the format as specified by the Company to serve in BSNL for a period of five years from the date of their appointment as Rajbhasha Adhikari, in the proforma as prescribed by the Company. The candidates selected by mode of direct recruitment shall have to successfully undergo training as per the training plan laid down by the Company before their appointment as Rajbhasha Adhikari. During the period/of training, the direct recruit Rajbhasha Adhikari will be entitled to stipend (training allowances) as decided by the Company from time to time.
- 9. Saving:- Nothing in these rules shall affect reservation, relaxation of age limit and other concession required to be provided for the Schedule Caste, Scheduled Tribes, other Backward Classes, Ex-servicemen and other special category of persons in accordance with the orders issued by the Central Government from time to time in this regard.
- 10. Power to Relax: Where the B.S.N.L. is of opinion that it is necessary or expedient so to do it may, by order, for reasons to be recorded in writing and with the approval of Management Committee of B.S.N.L. relax any of the provisions of these rules in respect of any class or category of persons.

11. Initial constitution:-

- (i) All office s holding the post of Assistant Director (Official Language) on regular basis in erstwhile DoT/DTS/DTO before commencement of these rules and those who have been absorbed in Bharat Sanchar Nigam Limited shall be deemed to have been appointed as Rajbhasha Adhikari with the same seniority.
- (ii) The continuous regular service of officers referred to in sub-rule 11(i) above before the commencement of these rules shall count for the purpose of probation, qualifying service for promotion, confirmation and pension.
