In addition it may be ensured that;


- a) Before relieving the officer, no disciplinary / vigilance case is pending against the officer.
- b) The service book and initial recruitment file containing all recruitment documents such as Bond Agreement, Sureties letter, Community Certificate etc and copies of appointment order & confirmation order are either available in PF or in service book.
- c) Up to date APAR may also be forwarded to concerned circle while relieving the officer.
- d) The date of relief / joining time may be intimated to all concerned.

The officers may be instructed to report to the AGM (Admn) of respective Telecom Circle, for their station of posting..

**NOTE:**

1. JTOs at Sr. No 3 & 9 of annexure – A may be relieved only after completion of two years of service at present SSA.
2. JTOs at Sr. No 23, 24, 25, 28 & 41 may be relieved only after receipt of consent from concerned circle and confirmation from this office.
3. JTOs under transfer may be relived as per administrative convenience only
