❖ **Manner in which election will be conducted:**

- ✓ Online nomination will be called for new circle governing body of AIGETOA TS circles for any posts ( CP / CS / CFS / 6ACs / 2CVPs ) has to mail to [rotsaigetoa@gmail.com](mailto:rotsaigetoa@gmail.com) from 07<sup>th</sup> OCT 2020 to 15<sup>th</sup> OCT 2020. Any valid member of the association can file his nomination.
- ✓ The provisional list of nominations for the election of new governing body of AIGETOA TS will be displayed on 16<sup>th</sup> OCT 2020.
- ✓ Verification of the nomination received will be done by the returning officer in consultation with concern District secretaries from 16<sup>th</sup> OCT-20 to 18<sup>th</sup> OCT 2020.
- ✓ Nomination can be withdrawn between 17<sup>th</sup> OCT-20 to 18<sup>th</sup> OCT 2020 on written request to [rotsaigetoa@gmail.com](mailto:rotsaigetoa@gmail.com)
- ✓ Final list of nomination received will be displayed on 19<sup>th</sup> OCT 2020 through website/Whatsapp/online.
- ✓ Any person from the final list of nomination can contest for any post in the circle governing body as per the provisions and in adherence to the constitution of AIGETOA. If one cannot be elected for one post he can contest for next post.
- ✓ Sequence of election for the post will be decided by the Returning Officer in consultation with the district representatives present over there.
- ✓ Voting for election of TS circle office bearers will be done by electoral collegiums of Telangana Circle as per provision of constitution. The Districts have to give the names of collegiums based up on their no. of paid strength by 16<sup>th</sup> OCT 2020. Finalized the list of collegium and will be displayed 19<sup>th</sup> OCT 2020.
- ✓ Last date for submitting the District Financial report for the FY-2018-19, 2019-20 is 15<sup>th</sup> OCT & District Secretary report by 17<sup>th</sup> OCT 2020 in given format. Non submission of it, those SSA/Units will not be allowed to cast their votes.
- ✓ Any objections on the list of collegiums of the Society entitled to vote or members to be elected as circle governing body of AIGETOA TS circle shall be decided by the Returning Officer & CHQ observer. However, the decision of the Returning Officer shall be final in the event of any difference of opinion.
