## **Procedure for election:**

- \*Nomination will be called for new Circle body of Maharashtra before actual election. Any valid member of the association can file his nomination.
- \*Verification of the nomination received will be done by the returning officer in consultation with concern District Secretaries and if body is not existed in the district of nominee belongs, then the eligibility of nominee will be decided by returning officer in consultation with the CS and CP, subject to nominee should pay all the subscription dues.
- \*Valid nominations will be declared in meeting before conducting the election.
- \*Any person from the final list of nomination can contest for any post in the governing body as per the provisions and in adherence to the constitution of AIGETOA. If one can not be

elected for one post he can contest for next post.

- \*Nominee can with draw his nomination before proceeding of the election starts.
- \*Sequence of election for the post will be decided by the returning officer in consultation with the circle representatives present over there.
- \*Voting for election of Circle office bearer will be done by the electoral collegiums i.e. delegates from among valid members and elected district representative from each district. These names will be taken by DS/DP of each SSA and voting power will be delegated to them by returning officer.
- \*Any objections of the list of collegiums of the Society entitled to vote or members to be elected as Circle body of AIGETOA shall be decided by the Returning Officer in consultation with the Circle office-bearers of the society. However, the decision of the Returning Officer shall be final in the event of any difference of opinion.
