## Manner in which election will be conducted:

- 1. RO will invite the nomination for collegium members from each district body based on number of electoral colleges allotted to each district by **07-Mar-2021**. List of collegium members will be decided by district bodies.
- 2. RO will display the list of collegium members so nominated from each district body on web site or whatsup group for any objections/ omissions. Any objection in the list of nominated collegium members will be decided by RO in consultation with CS. However, the decision of RO will be final in the event of any difference of opinion. Thereafter, RO will declare final list of collegium members and will submit its signed copy to CS. Separate intimation to respective District Secretaries has already been sent in this regard.
- 3. Final Electoral roll in respect of AIGETOA Tamilnadu Circle i.e., collegium list will be displayed at <a href="https://www.aigetoachq.org">www.aigetoachq.org</a> by <a href="https://www.aigetoachq.org">11-Mar-2021</a>.
- 4. Online nominations for post of (CP / CS / CFS / 6ACSs / 2CVPs) will be invited through website/link for new governing body from **18-Apr-2021 to 20-Apr-2021**. Any valid member can file the nomination.
- 5. Nominations can be withdrawn from <u>21-Apr-2021 to 23-Apr-2021</u> by writing mail to RO at roaigetoatncircle@gmail.com only.
- 6. Final nominations received will be displayed at www.aigetoachg.org on 24-April-2021.
- 7. Sequence of election will be decided by returning officer in consultation with district collegium and decision of returning officer will be final in this context.

- 8. Any person from the final list of nominations received can contest for any post in governing body as per provision and in adherence of the constitution of AIGETOA. If one can't be elected for one post can contest for next post.
- 9. Voting of election of circle bearers will be done by the electoral collegiums as per provision of constitution through online mode.
