- ✓ Returning officer(s) for conducting election: Shri P. N. Sharma, Circle Secretary, AIGETOA, Rajasthan and Shri Abhishek Chaudhary, Circle President, AIGETOA, Rajasthan.
- ✓ Date, Time and venue of Election of Circle governing body: 24th July 2016 from 15:00 hrs at same Meeting place as above.
- ✓ Declaration of result: 24th July 2016 at 17:00 hrs
- ✓ Manner in which election will be conducted:
 - i. Online nomination will be called through AIGETOA Punjab website www.aigetoapb.weebly.com for new governing body of AIGETOA Punjab from 1st July 2016 to 10th July 2016. Any valid member of the association as on 1st July 2016 can file his nomination

- ii. List of existing Electoral College i.e. collegiums will be decided as per average membership from different District units with cutoff date 30th June 2016 for present year. However every participating delegate should be a valid member of association as on 1st July 2016. Final list of Electoral College will be displayed on 2nd July 2016.
- iii. Verification of the nomination received will be done by the Returning Officer in consultation with Circle Secretary, Punjab from 11th July 2016 to 13th July 2016.
- iv. Provisional list of the nomination received will be displayed on AIGETOA Punjab website on 14th July 2016.
- v. Nomination can be withdrawn between 14th July 2016 to 16th July 2016 on written request to returning officer through hard copy or electronic media like e-mail.
- vi. Final list of nomination received will be displayed on 17th July 2016 on AIGETOA Punjab website.
- vii. Any person from the final list of nomination can contest for any post in the governing body as per the provisions and in adherence to the constitution of AIGETOA. If one cannot be elected for one post he can contest for next post.
- viii. Sequence of election for the post will be decided by the returning officer in consultation with the District Representatives present over there.
- ix. Voting for election of Circle Office Bearer will be done by the electoral collegiums as per provision of constitution.
- x. Any objections on the list of collegiums of the Society entitled to vote or members to be elected as governing body of AIGETOA Punjab shall be decided by the Returning Officer in consultation with the office-bearers of the society. However, the decision of the Returning Officer shall be final in the event of any difference of opinion.
