Dear Sir,

We would like to draw your kind attention towards the serious ramification of the order issued by the DPE on 19th November, 2020 regarding freezing of Dearness Allowance to Employees of all Central Public Sector Enterprises (CPSEs) drawing pay as per 1987, 1992, 1997, 2007 & 2017 IDA Pay Revision guidelines at current rate till 30th June, 2021. It becomes more hurting to BSNL employees, where the proposed 3rd PRC wef 01.01.2017 was not implemented till date citing the profitability clause.

It is need of the hour to have a common response against such order which inflicts damage to the basic rights of our fellow employees and needs to be opposed with full strength and unity among all stake holders. I was in touch with various unions and associations on the subject for a common consensus but unfortunately couldn't succeed for a joint common call. To protest against the DPE Order, many of the platforms have served the letter to observe lunch hour protest including yours. Even at this belated stage, I will request all representatives to hold a dialogue to have a Common Protest to send a unified voice against this suppressive measure of the government and strongly demand the roll back of the Order.

So, I once again emphasize that it will be in the larger interest of employees if we all could arrive at a common protest call against the order of Dearness Allowance freezing to employees of all CPSEs. Even, if it couldn't achieve now, I extend my support to your Lunch Hour Protest Call as referred above with a hope that you will extend your cooperation in our endeavor to reach a consensus in future as well as support our various programs to fight against the suppressive measure and roll back of the order.
