**Subject: Immediate conducting DPC for long awaited promotion in AGM (T) Grades in view of the judgment by Hon'ble Supreme Court and issuance of instruction by the DOPT in the matter of Reservation –Reg.**

**Respected Sir,**

I would to take this opportunity to convey congratulations for surpassing the targets of collection in a handsome manner in March'2022 in just concluded FY 2021-22 with combined efforts of management, Employees and Channel Partners of BSNL. This has created a positive vibes in the market and organisation and a strong believe to achieve with suitable resources. At the same time, issues pertaining to Employees needs to be taken up on priority e.g. Standard Pay Scale, Promotions, Proper Medical Care, Pending Superannuation Benefits of BSNL Recruited Employees and restoration of discontinued facilities to infuse motivation in the Employees and contribute more and more.

In continuity, I would like to draw your urgent attentions on long due promotions in the AGM(Telecom) and other Grades due to litigation in the matter of Reservation in Promotion. ***Hon'ble Supreme Court has delivered judgment on the matter on dated 28th Jan'2022 in Jarnail Singh & Ors Versus V. Laxmi Narain Gupta Case & Ors (Civil Appeal No 629 of 2022 arising out of SLP(C) No 30621 of 2011) and directing DOPT to issue clarification. In accordance with the judgment of the Hon'ble Supreme Court, the DOPT has come up with the direction vide OM 6012/16/2019-Estt. (Res.) dated 12.04.2022 on the matter. It has categorically mentioned in the said OM that the appointing authority can issue the promotion observing the instruction in the OM.*** In this direction the preparatory readiness has also been made by uploading grading/remarks of APAR of the offline period to expedite the process as per referred letter #2. Now only a categorical direction is required from your benign authority to initiate the process as per assurance given to us on multiple occasions.

**Therefore in view of the of judgment by the Hon'ble Supreme Court on 28.01.2022 and issuance of instructions by the DOPT on 12.04.2022, we earnestly request for directing concerned Unit for immediate start of DPC Process for the issuance of promotion in the grade of AGM(Telecom), considering the field requirements and the long pendency of the promotions to the AGM grade.**
