Sub: Response to your letter to the CMD BSNL regarding issuing presidential orders to the employees, recruited and sent for training by DoT, prior to 01.10.2000 and who joined duty after formation of BSNL, requesting to treat them as DoT recruitees, based on the criterion laid down by the Department of Pension & Pensioners' Welfare – Reg

Dear Sir,

I am writing on behalf of the All India Graduate Engineers & Telecom Officers Association (AIGETOA) to address a matter of crucial importance that directly affects the livelihoods and future security of a dedicated segment of BSNL employees who underwent recruitment process which initiated before the formation of BSNL by DoT but joined duty after formation of BSNL. This situation has led to a considerable predicament concerning their employment status and pension rights.

Our association initially raised this concern through the letter cited under reference 3. Subsequently, BSNL forwarded our communication to the DOT, as indicated in the letter referred to under reference 2. In response to these correspondences, your office provided certain observations in your letter addressed to the CMD BSNL, which is outlined in the communication referred to under reference 1.

However, it is crucial to note that the observations outlined in your letter <u>do not align</u> with the historical precedence set by the Department of Telecommunications in similar cases, nor do they conform to the legal determinations rendered by various courts in relation to this issue. Additionally, your observations appear to be at odds with the criteria established by the Department of Pension & Pensioners' Welfare in matters of this nature.

In light of the aforementioned considerations, we kindly request your reconsideration of the matter. To facilitate this, we have prepared a point-wise reply to the observations presented in your letter. This reply encapsulates our perspective and rationale, supported by existing regulations, legal judgments, and relevant precedents. We earnestly hope that you will take into account these crucial factors and reconsider your stance on this matter.

Your observations

- (i) That the policy/stand of DoT with regard to the status of all such employees is quite clear and has already been clarified vide this office letter no. 27-01/2001-SNG(Vol.III)/Chennai T.C(Pt.) dated 27.02.2020 read with corrigendum dated 23.02.2021, that "any employee who has been formally appointed by BSNL on or after 01.10.2000 and joined BSNL, is BSNL appointee." Therefore, issuance of Presidential Order or the applicability of CCS (Pension) Rules, 2021 do not arise for a BSNL appointee.
- (ii) That Rules 37 of CCS(Pension) Rules, 2021 states that Pension is paid to combined service employees only, who were on the rolls of DoT before corporatization of DTS/DTO and were en-masse transferred to BSNL/MTNL and were absorbed therein as per the option exercised by them. Since employees referred in the representations had not rendered services in DoT, they were not entitled for absorption process and CCS (Pension) Rules 2021 are not applicable to them.

Our reply to Point i &ii

Prior to the formation of BSNL, the DOT issued telecom circle-wise recruitment notifications for the direct recruitment of Junior Engineers (JE) Electrical. The recruitment examination was conducted by the DOT, and successful candidates were subsequently inducted into BSNL after formation of BSNL. They were ultimately appointed by BSNL and were granted pensionary benefits under CCS (Pension) Rules 1972, as per DOT letter No. 19-14/2000-EW dated 8.8.2002. Presidential orders also issued to these JE Electrical mentioning date of appointment and date of absorption as same.

The circumstances outlined above stand in stark contrast to the assertions made in your points i and ii. Same class of employees cannot be treated as differently. This discriminatory treatment constitutes a clear violation of their constitutional right of equality before the law.

The supporting documents regarding appointment JE Electrical in BSNL is enclosed for your ready reference.

Your observations

(iii) That DoPPW OM dated 03.03.2023 further circulated by Pension *Section,* DoT Hq. vide OM dated 07.04.2023 clearly states that the said OM is applicable to Central Government Civil Employees only. DoPPW OM is no *where* linked to BSNL employees.

Our reply to Point (iii)

While it is indeed true that the DoPPW OM dated 03.03.2023 is explicitly tailored for the realm of Central Government Civil Employees, a similar line of reasoning can be applied to a specific subset of BSNL employees who underwent recruitment process which initiated before the formation of BSNL by DoT but joined duty after formation of BSNL.

Incorporating analogous principles, various judicial verdicts within the subject domain firmly establish that the service conditions existing at the initiation of the recruitment process must not be subjected to unfavourable alterations against the recruits.

We deeply appreciate your attention to this matter and your commitment to the welfare of above said employees. We anticipate a just resolution that safeguards the rights and interests of the concerned employees.

I am directed to refer to your office letter No. 48-2/2023-Pen(B) dated 12.06.2023 and letter dated BSNLEU/511(Rectt.) dated 12.05.2023 received from General Secy. BSNL employees Union on the above mentioned subject. On examination of the matter, the following observations have been made:

- (i) That the policy/stand of DoT with regard to the status of all such employees is quite clear and has already been clarified vide this office letter no. 27-01/2001-SNG(Vol.III)/Chennai T.C(Pt.) dated 27.02.2020 read with corrigendum dated 23.02.2021, that "any employee who has been formally appointed by BSNL on or after 01.10.2000 and joined BSNL, is BSNL appointee." Therefore, issuance of Presidential Order or the applicability of CCS (Pension) Rules, 2021 do not arise for a BSNL appointee.
- (ii) That Rules 37 of CCS(Pension) Rules, 2021 states that Pension is paid to combined service employees only, who were on the rolls of DoT before corporatization of DTS/DTO and were en-masse transferred to BSNL/MTNL and were absorbed therein as per the option exercised by them. 


As the matter relates to benefits under CCS (Pension) Rules 1972, (Now 2021) the same is being forwarded for consideration please."

CMD Remarks Forward to DOT for issue of clarification.

Letters received from various Unions / Associations regarding issue of Presidential order for absorption (thereby entitling them the benefits under CCS Pension Rule, 1972) to all such employees of BSNL who were recruited and sent for training by the DOT prior to 01 10 2000 and who may have joined duty after the formation of BSNL.

This demand has amanated in the wake of letter of DoP&PW OM No. 57/05/2021-P&PW(B): Dt.03.03.2023, whereby Central Civil Service (Pension) Rules-1972 has been extended in place of National Pension System, of those Central Government employees who were recruited against the posts / vacancies advertised / notified for recruitment, on or before 22.12.2003.
