Subject: Request for notification of LDCE for JTO(T) to SDE(T) Promotion against 33% quota in SDE-Reg.

Respected Madam,

We would like to invite your kind attention towards inordinate delay in conduction of LDCE for Promotion to the post of SDE(T) under 33% quota in SDE cadre. You will appreciate our concern that period elapsed since last notification of LDCE for SDE(T) is too long and our executive fraternity is extremely anxious and dejected due to this excessive delay. The sequences of events for last conducted LDCE are as under:

Date of LDCE Notification issued	: 13.11.2014	Issued notification for four combined vacancy Yrs 2010-11, 11-12, 12-13 & 13-14 (cancelled)
Date of revised LDCE Notification	: 20.04.2015	Issued for single vacancy year 2010-11
Date of Exam held	: 21.06.2015	for vacancy year 2010-11
Declaration of result	: 21.05.2016	for vacancy year 2010-11
Promotion order issued	: 25.05.2018	for vacancy year 2010-11

The above details clearly depict that the fast track channel for promotion to the post of SDE(T) has some where missed the bus causing severe delay in the opportunity to eligible executives. Last LDCE notification issued for vacancy year 2010-11 in 2015 and since then no notification have been issued even after laps of four years while the LDCE is pending for eight (8) vacancy years i.e. 2011-12, 2012-13, 2013-14, 2014-15, 2015-16, 2016-17, 2017-18 & 2018-19.

The qualifying service to appear in the LDCE of SDE(T) is three years but your good self will acknowledge that JTOs, who have even completed 9-10 years of service is still awaiting to appear very first time in LDCE for SDE(T). It is further to apprise here that more than 7000 posts in SDE(T) are lying vacant under the two stream of promotion i.e. LDCE & SCF, while on other side promotion are happening in almost all streams/post. This is a very disappointing situation for BSNL Recruited Executives as they are losing their precious time in the career even being employee having longest life in BSNL but waiting endlessly for their first promotion.

Therefore in the light of above facts, it is requested your good self to kindly pass an order as deemed fit for issuance of notification for LDCE against 33% quota of SDE(T) for successive vacancy years w.e.f. 2011-12 onwards. The calendar should include the schedule of examinations for all vacancy years to avoid any legal problem, arising out of desperation of candidates who are not eligible for a particular vacancy years, with a gap of 1-2 months between each vacancy year. We are looking forward for a favorable decision on merit.
