Respected Sir,

We would like to draw your kind attention towards severe hardship faced by employees of BSNL due to delay in disbursement of salary for the month of August-2019. It's the second time in the current FY that salary has not been disbursed to employees on due date. You will appreciate that the regular expenditure of household of most of us directly depends on the salary this includes Loan EMI, School/College Fees, medical expenditure, LPG payment, transportation, electricity Bill and other routine expenditures. This situation has created a serious mental agony for all of us to maintain our family while continuing our social responsibility. The condition of young BSNL recruited employees are more critical owing to no backup and being in mid of their career with different liabilities. We are confident that our BSNL Board will be doing their best to come out of the crisis but we still feel that the situation should be appraised more loudly to the parent ministry to overcome the problem.

At the same time, there is a feeling of anxiety across employees on the present situation of the company and delay in implementation of proposed revival plan. The widening gap of revenue and expenditure with each passing is making the things more difficult especially in absence of required financial support to maintain services across all verticals. This necessitates immediate implementation of the propose revival measures else the desired result may not be achieved.

Therefore, we would like to request you to kindly take cognizance of the situation and use your good office to apprise in the government about early implementation of proposed revival plan of BSNL. Even delay of single day is costing us dearly and pushing us back further. Also, delay in disbursement of salary is further adding fuel to fire by increasing uncertainty in the minds and hearts of people and hence needs immediate redresser.
