Subject: Preparation and circulation of provisional seniority list-9 of SDEs from 2006-07 to 2008-09 in line with ROTA-QOTA Rule of inter-se-seniority of 2:1 between SCF and LDCE respectively.

Respected Sir,

We would like to draw your kind attention towards the fact that even after assurance of your good self on multiple occasions and our representation dated 20.06.2019, 16.09.2019 as referred above, the much awaited SDE seniority list-9 has not been circulated. The inter-se-seniority list of SDEs promoted through SCF and LDCE for the vacancy year 2006-07 onwards is pending since 2013. It is important to note that various tasks associated with the list has been completed and corporate office has already circulated separate list of DPC & LDCE qualified SDEs from 2006-07 to 2008-09 to call for error & omission from individuals in 2016 vide letter under reference #3. Now, the only works remaining for circulation of provisional seniority list-9 is placement of SDEs of both stream (DPC & LDCE for particular vacancy year) to make a composite year wise seniority list from 2006-07 to 2008-9.

As discussed in the meeting held under chairmanship of the Director (HR) on 16th Nov-2019, it was assured that the provisional seniority list-9 will be published in a month time i.e. before 15th Dec'2019; it is requested to meet the date as assured as the same has been failed on many occasions. Further, as per information, ROTA-QOTA principle for inter-se-seniority in 2:1 format w.r.t. to SCF and LDCE promoted SDEs respectively has been passed in management committee, it is requested to take it as a guiding principle while preparing the SDE Seniority list-9 for vacancy year 2006-07 onwards. It is further requested to complete all pre-formalities for circulation of provisional list-9 in time.

It is therefore, once again requested to frame the seniority list in 2:1 format and arrange circulation of provisional seniority list -9 in the stipulated time, which is one of the most awaited requisite of the SDEs. We are looking forward for your kind concern and timely implementation in this regard. Encl. As above
