Subject: SDE Reversion issue and implementation of the Hon'ble CAT, Chennai order dt 22.11.2019-Reg.

Respected Sir,

This is in continuation of our previous discussion regarding one time settlement of the SDE reversion cases of those covered under SDE RR 2002 as on date of the examination i.e. 15.07.2007. Kindly also refer the discussion held in the agenda meeting held on 16.11.2019 in the chamber of the Director (HR) and the probable solution to consider 2001 JTOs, who were covered SDE RR as on date. All such candidates declared their service periods without concealing anything while applying for the LDCE-2007 examination and the Circle allowed them to appear in the light of existing provisions of SDE RR 2002 and clarifications issued by the Corporate Office before the examination I.e. 15.07.2007 and later these candidates joined as SDE(T) on successful completion of the process.

In this series some candidates of the Tamilnadu Circles approached court of law when they were served notice for reversal and after a series of legal fight which continued for almost a decade, a reversion order was issued to these candidates on 06.09.2019 by the Corporate Office, New Delhi. Then these candidates again represented to the Hon'ble court and finally a speaking order was issued by the Corporate Office on 13.11.2019 disposing of their claim for SDE in response of the court order. Again, to seek relief against the speaking order, the applicants approached the Hon'ble CAT Chennai, which passed an interim order based on OA No310/01518/2019 dated 22.11.2019. This order directed the administration to keep the reversion order dated 13.11.2019 and all the consequential orders in abeyance till the review petition are disposed of (copy enclosed). But the said order of the Hon'ble CAT has not been implemented so far and these executives have not restored back to SDE(T).

Hence, it is requested that all such executives who received notice or reversion but covered the eligibility criteria as on the date of examination i.e. 15.07.2007 under SDE RR 2002 and served more than ten years in the SDE Grade should be allowed to work as SDE(T). It is further requested to implement the Hon'ble CAT Chennai Order dated 22.11.2019 in true spirit to keep the reversion order dated 13.11.2019 and all the consequential orders in abeyance. We are looking forward for decision on merit considering the then rule position as well as serving of executives for more than a decade on the post of SDE(T). Another stay order bearing OA NO 810/1642/2019 has been granted by the Hon'ble CAT restraining BSNL from executing reversion order dated 24.09.2019 and all consequent orders.
