## Respected Sir,

This is in continuation of our earlier submission and personal persuasion that SDEs promoted through LDCE-2007 after being declared eligible under Clause-12 (5) by their respective circles were very much valid on the date of examination i.e. 15.07.2007 as per the prevailing RR. We have submitted several documents and instance showing their valid claim and justified their promotions through documents. We have explained about the issue in detail through the referred letter at #4 and #5.

Further, in our agenda meeting on 16<sup>th</sup> November, 2019, we explained the issue with documents to your good self also and it was agreed in the meeting that the matter will be settled and those SDEs will not be reverted, who were eligible through Clause-12 (5) of SDE RR 2002 as on 15.07.2007. The clause 12 (5) of SDE RR 2002 says that , "Where juniors who had completed their qualifying eligibility service are being considered for promotion, their seniors would also be considered provided they are not short of requisite qualifying/eligibility service by more than 1 year."

Therefore, we request you to kindly issue suitable direction to resolve the issue by allowing them to work in SDE (regular) as per their promotion order and the issue may be closed accordingly as a onetime measure by the Personal Section, CO New Delhi. This will allow these executives to concentrate and work with peaceful mind towards the development of the BSNL instead of getting them distracted and running pillar to post indefinitely to seek justice for their legitimate claim. We are very hopeful that an early and rightful decision will be issued in larger interest of the department and to extend justified claim.
