Respected Sir,

We would like to draw your kind attention towards the recent schedule of SIX WEEKS JTO Phase-II training w.e.f. 14.09.2020 to be conducted at ALTTC Ghaziabad comprising of 67 JTOs under various specializations as announced by the ALLTC Ghaziabad vide letter under reference in this Pandemic situation. The six weeks duration of stay at the training centre to carry out the JTO Phase-II training in this situation where the Covid-19 situation is continuously on rise is giving serious anxiety among candidates. Many of the candidates have approached their respective unit/circle to either make it online mode or reschedule the date. The candidates have approached the association also to take up the matter at appropriate level considering the present situation.

There are about 67 candidates from Karnataka, Gujarat, Bihar, UP (East) and UP (West) who has to undergo six weeks JTO Phase-II training on the schedule wef 14.09.2020. You will acknowledge that even today about 90,000 in the country and 6500+ in Uttar Pradesh Covid-19 cases are reported daily posing a serious threat of contamination from the Pandemic. In this situation, staying away from home for six weeks duration and using common places regularly is a real threat to their safety. However the phase-II training is equally important to be carried out in time as the 2nd increment is linked with it.

Therefore, you are requested to kindly look into the issue and find out a workable solution either by arranging online phase-II training or reschedule the training for later date, till the ease out of Pandemic, with a direction to all Circles that 2nd increment shouldn't be withheld on this account as one time measure in the present Covoid-19 circumstances.
