Subject: Ensuring of free, fair and transparent election of 2<sup>nd</sup> Membership Verification scheduled on 18.08.2020 in sensitive SSAs of UP West Circle-Reg.

## Respected Sir,

I would like to draw your kind attention towards the serious anomalies and non-conducive environment prevailing in some parts of UP West Circle e.g. Ghaziabad, Agra, Noida, Bijnore etc for free and fair election process as reported by our Circle Secretary vide letter under reference.

In this regard, it is requested to take suitable measures to instill confidence among the eligible voters (working executives) to use their democratic right to vote fearlessly and frankly instead of the pressure of some corners as well as ensure strict adherence of all laid down rules to conduct the free and fair election. In this regard, we suggest following measures for all sensitive booths including those mentioned above to conduct the 2<sup>nd</sup> Membership Election on 18<sup>th</sup> August, 2020 as per norms:

- Appointment of external observer to carry out the process as per the norms.
- Carrying out of webcasting/videography of the entire process of polling day/counting day.
- Deputation of Civil administration in and around polling booth on polling day and counting day.
- Strict compliance of the SR Cell guidelines in this regard.
- Entry of retired employees should be strictly prohibited on polling/counting day in the building.
- Certificate of compliance of all measures wrt polling and counting process by the SSA Heads.

Therefore it is requested to consider above measures and implement them to ensure free, fair and transparent election process of 2<sup>nd</sup> Membership Verification as per laid down procedures and guidelines.
