
Respected Sir,

Please refer to the letter cited above regarding repatriation order of 66 JAO's from the borrowing Circle(s) to their Parent Circle(s) by Corporate Office on completion of 3 years of service in the current Circle on the following grounds:

1. All these JAO's are actively involved in closures of accounts of FY 2021-22 and this transfer order will affect the time bound closure on PAN India basis. At this young age, all these JAO's are working hard to rebuild the BSNL and contributing in the efforts to bring BSNL again in its golden era.
2. It is pertinent to mention that all 66 JAOs got transfer under rule 9 on the spouse ground, self illness as well as critical illness of parents and spouse etc. Most of the JAOs got recently married and having small children, so the care for own family also required in this stage.
3. These JAOs were came to borrowing Circle before the amendment made in BSNL Transfer Policy in the Sep' 2021 and as per then policy maximum period of Rule 9 was 5 years.
4. It is important to apprise here that one side Executives with more than 26 years of service are staying in the Circle against the laid down rules in the BSNL Transfer Policy, where as these JAOs were on temporary transfer and hardly completed Three Years in the current Circle. So one side order is being issued to relieve them citing the policy provision other side the policy norm is completely ignored in case of longest stay 26 years transfer cases.

In view of the aforesaid ground, it is humbly requested to retain these JAOs for at least one year considering their hardship.
