## Respected Sir,

An organisational call was given by AIGETOA vide referred letter to seek attention of management towards resolution of long pending issues of Pay, Pension and Promotions. In series of discussions, two important meetings were held under chairmanship of Director HR on 14.07.2022 and 29.07.2022 with the representatives of Association and detailed discussions were held on each and every issue. Firm assurances have been extended to us and it was affirmed to us that action in black & white will be visible very soon on all burning HR issues. Further assurance by your good self on the issues has also given us confidence that there is still hope for amicable resolution, provided HR Team of BSNL, shows an honest intent to settle the issues through mutual discussions and dialogue. The suggestion from Management to have weekly review on the progress of issues has also given us the reason to believe that management is serious in settling the issues and it will be implemented in true spirit instead of a mere assurance.

In the meanwhile, second revival package has also been extended by the Government of India and it is felt that the path to recovery, which was diminishing day by day has again came back on track. We are indeed grateful to our Hon'ble Prime Minister Shri Narendra Modi Ji and our Hon'ble Minister of Communication Shri Ashwini Vaishnaw Ji for ensuring the second revival package for BSNL by overcoming all odds. We are also thankful to your good self for your sustained efforts in precipitating the process, which finally resulted into extension of this revival package to BSNL.

We also had an opportunity to meet our Hon'ble MoC Shri Ashwini Vaishnaw ji on 29.07.2022, wherein we extended our thankfulness and gratitude to Government of India on behalf of BSNL Executives. In the meeting, detailed discussions were also held on HR issues pertaining to BSNL and it was a pleasant surprise for us to note that Hon'ble Minister was aware of the issues and he extended his firm support on genuine issues and advised us to concentrate on reaping the benefits of second revival package, which is in fact the last chance extended to BSNL for recovery. The positive vibes emanating from the words of our Hon'ble Minister has also rendered a new confidence in our minds that the long pending genuine internal issues of BSNL including those related to HR will also be resolved in positive and time bound manner.
