Subject: Enhancement of Posts of Principal Private Secretary (PPS) at BSNL Corporate Office – regarding.

## Respected Sir,

This is to apprise that sanctioned strength of PPS and Sr.PPS grades at BSNL Corporate Office has been considerably reduced after restructuring causing stagnation of the executives working in PS grade despite completing the qualifying service of seven years. After restructuring, current strength is as follows:

At BSNL Corporate Office, New Delhi: PPS-03 posts, Sr PPS-03 posts

At Field Units across the India: PPS-37 posts

It is worth to note that posts of PPS and Sr.PPS at BSNL Corporate Office were created to contribute in the secretariat of senior most functionaries of BSNL i.e. CMD and Board of Directors of BSNL and CVO, New Delhi. After restructuring there is no change in composition of the existing structure but PPS and Sr.PPS Posts were reduced drastically at BSNL CO New Delhi. This has created a situation, where eligible PS Grade Executives posted at BSNL CO would be stagnating in the same grade for 15-20 years till Superannuation.

It is noted that in Circle wise distribution of PPS posts, only 35 posts out of 37 posts were earmarked to various field units of BSNL vide letter L.No. BSNLCO-RSTG/15(14)/2/2021-RSTG-Part(2) Dated 09.02.2022 and 2 posts of PPS out of 37 PPS posts are yet to be allocated. After examination, it has been noticed that that there are number of Telecom Circles /Field Units, where PPS posts has been earmarked but no incumbent is available with 7 years qualifying service in PS grade to be promoted as PPS causing the posts remain unfilled. Whereas many Secretarial functions in the Senior Management Officers in BSNL Board are at present being temporarily managed by PA/PS despite of many eligible executives completing 7 years of qualifying service for PPS.

In view of above, it is requested to earmark these two PPS posts of field units to BSNL Corporate Office, which has not been allotted so far to the field without disturbing the overall strength. Further PPS/Sr PPS posts may be created along with AGM(T)/CAO and other equivalent grades in view of BBNL merger to provide proper career opportunity to eligible incumbents available in the organisation.
