**Sub: Request for consideration of the promotion of LDCE-2015 qualified candidates from JTO to SDE(T) – those who have cleared the minimum cut off marks but could not be promoted due to non-availability of vacancies.**

Respected Madam,

I would like to draw attention towards the plight of the left out candidates in LDCE-2015 JTO to SDE(T) who qualified the exam by obtaining the minimum cut off marks (i.e. 50 marks in both paper) but could not be promoted due to non-availability of vacancies against 2010-11. It is understood that around 1687 candidates in general category have secured the minimum 50 marks in both paper. Out of these 1687 candidates, only 1443 have been promoted while others (around 244) could not be promoted due to non availability of vacancies under the OC category for the vacancy year 2010-11. It is a matter of fact that in all earlier LDCEs for JTO(T) to SDE(T) promotions were granted to all candidates who secured the minimum qualifying marks.

2. Vide letter No. 4-19/2007-SEA dated 10-10-2018(Copy enclosed), SEA section of BSNL CO has asked data from circles for the candidates of the JAO LICE held in 2006 / 2009 / 2012 / 2016 who got the minimum qualifying marks but could not be promoted due to not coming in the Merit list due to non availability of vacancies in their circle in respective Quota.

3. AIGETOA has already represented in July-2018 for granting promotion to the left out qualified candidates of LDCE -2015 JTO(T) to SDE(T). It is once again requested to consider the grievances of left out LDCE-2015 qualified OC candidates who have cleared the cut off marks but could not be promoted and promotion orders may be issued in respect of these left out candidates.

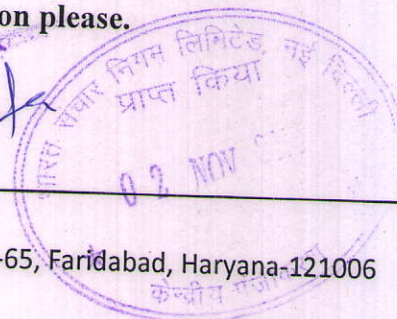


