
**Subject:-Limited Departmental Competitive Examination for promotion to the grade of Sub-Divisional Engineer (Telecom) under 33% Quota to be held on 21.06.2015 - arrangements for holding of Exam reg.**

Sir,

I am directed to refer to this office letter even No. dated 13-11-2014 in which it was decided to hold the Limited Departmental Competitive Examination for promotion to the grade of Sub-Divisional Engineer (Telecom) under 33% quota on 15-02-2015 and this office letter even No. dated 13-02-2015 vide which the said examination was deferred till further orders due to multiple Court verdicts resulting into contradictions and administrative constraints thereto.

2. Now, in view of legal issue, the Competent Authority has decided to hold the aforesaid examination on **21-06-2015** for the vacancy year **2010-11 only** and only those JTO (T), who have already submitted online application form and are eligible for the vacancy year **2010-11** shall be allowed to sit in the examination as per the following schedule:


4. The unfilled/back log vacancies up to 2009-10 (SC-285, ST-377) shall also be filled up against the vacancy year 2010-11.

5. The examination will be conducted as per Scheme and Syllabus of examination circulated by Personal Branch BSNL CO. vide letter no. 2-16/2013-Pers.II dated 22.08.2014 and 10.12.2014.

6. The eligibility for appearing in the above mentioned Limited Departmental Competitive Examination shall be as per Recruitment Rules of SDE (T) published by Pers. II Section of BSNL HQ vide letter No. 20-24/2001-Pers-II dated 28.02.2002 and circulated vide letter No 20-1/2001-Pers.-II dated 06.03.2002 and amendments time to time and clarification issued by Pers. II section of BSNL CO vide their letter No. 2-16/2009-Pers.II dated 30.07.2010 and letter No. 2-16/2013-Pers.II dated 22.01.2015. However, in case of any doubt with regard to eligibility, the Scheme and Syllabus of the examination, the Circles may take up the matter suitably with the Pers. II Branch of the BSNL CO. for necessary clarification.

7. All other terms and conditions as mentioned in the earlier notification of even No. dated 13-11-2014 shall remain unchanged. The online registration done by the candidates w.r.t. aforementioned examination notice is valid for this exam and no fresh registration is required, but only those candidates who were declared eligible to appear in the exam against the vacancy year 2010-11, which was to be held on 15.02.2015 shall be eligible to appear in the examination now scheduled to be held on **21.06.2015**, accordingly the Hall permits issued earlier stands cancelled and candidates eligible for vacancy year 2010-11 will be issued fresh admit cards.

The examination will be conducted by the Heads of Territorial Circles including NTR, Chennai and Kolkota Telephone Distts. and will be held at such centers as may be fixed by them and any change (if any) in Exam Coordinator /Centre supervisor(s) already submitted to this office may be intimated with details latest by 20-05-2015.

For candidates of Chennai and Kolkota Telephones, the respective Heads of Telephones Distts. will conduct the examination.


