CMD desired, in the meeting, that Sr. GM (CA) will study the write up/ brief and will further examine with reference to infrastructure and other requirements regarding centralized EPF Account for employees covered under EPF and put up to Management of decision. To kick start primary work i.e. to interact with EPFO, to know the modalities etc. initially one AGM and one Accounts officer shall be posted immediately in CA Section. For starting the actual work subsequent to initial process, CA section will be requiring the following staff to manage the centralized EPF Account.

Hence, it is requested to immediately post one AGM & one AO/JAO to interact with EPFO, frame necessary modalities, suggest infrastructure, interface with ERP, migration of accounts, compliance required to avoid interest and penalties and prepare a detail and practicable report for implementation.
