Sub: Agitational programme by All India Graduate Engineers Telecom. Officers Association in support of their demands viz. mass protest before the Corporate Office followed by hunger strike from 18.8.2009 – reg.

Sir,

I am directed to refer to letter No. BSNL/7-9/SR/2009 dated 5.8.2009 followed by another letter dated 19.8.2009 of SR Cell on the above cited subject and to say that in spite of the clear instructions vide letters cited above, quite a number of Executives assembled outside Corporate Office 18.8.2009 & at Jantar Mantar from 19.8.2009 to 21.8.2009 and also absented themselves from duty, defying the Management's instructions under reference. The details of such Executives, obtained from various branch telephonically/in writing, is enclosed herewith at Annexure-I. In addition to these Executives, some more Executives whose names are not appearing in the enclosed list at Annexure-I, also might have participated in the mass demonstration and proceeded on unauthorized leave, the details of which should be available with the branch concerned.

2. As already advised by GM(SR) in his letter dated 19.8.2009, such striking employees, on resumption of their duty, should be given 'Show Cause Notice' for their unauthorized absence from duty and leaving their headquarters/place of posting without permission. In cases where the officials are not able to justify their absence from duty and/or leaving headquarters/place of posting without permission, suitable action be initiated for major penalty under BSNL CDA Rules, 2006.

3. In view of above, all the PGMs/GMs BSNL C.O. are kindly requested to take appropriate action in respect of the striking Executives posted in their branch under intimation to GM(Pers.).
