Please refer your letter referred to above giving notice for countrywide protest on 25<sup>th</sup> May, 2009 against the transfer of Shri Ramesh Prasad, JTO and Circle Secretary of All India Graduate Engineer Telecom Officers Association in Maharashtra Circle.


2. In your letter under reference, you have raised a number of wild allegations, viz. vindictive transfers, suppressing the SC/ST community members etc. against the management, which are not true. First of all, I would like to request you to find out the factual position of the case before you raise any allegations against the management.

As regards the transfer of Shri Ramesh Prasad, you are well aware that initially he was transferred to NE-I Circle based on the results of the competitive examination for promotion as SDE. On his request, the officer was retained in MH Circle and posted to Pune. Transfers and postings are made in the interest of service and not based on caste or creed of the officer concerned. In this regard, the Circle Secretary along with other members of the Association has also met CGM Maharashtra Circle on 2.5.2009 and the position has been explained to him, as well.

You would appreciate that BSNL management is not vindictive towards the demands and grievances of the All India Graduate Engineer Telecom Officers Association. **Any agitational action at this stage will neither be in the interest of the company nor will help the Association in resolving its grievances.** In the given circumstances, I request you to withdraw your notice for the proposed protest at Pune on 25.5.2009 and have the issues resolved through mutual negotiations.
