Sir,

In continuation of the earlier Trade Union Notice under reference above, it is hereby intimated that the BSNL and MTNL Executives and Non-Executives will organize two days Dharna in all SSAs/Circles/Corporate Office on the following demands:

- (1) All unabsorbed ITS officers should be forthwith relieved to DOT for true and just implementation of Absorption process OR All Employees, Absorbed/Recruited by BSNL & MTNL should be taken back to Govt service and permitted to work in BSNL and MTNL on deputation as in the case of unabsorbed ITS Group A officers.
- (2) Ensure financial viability of BSNL and MTNL by
 - (i) Immediate refund of BWA spectrum charges to BSNL & MTNL.
 - (ii) BSNL and MTNL should not be charged for the extra spectrum holding by them in excess of 4.4 MHz.
 - (iii) Adequate compensation for BSNL Rural Landline operations.
 - (iv) Exempt BSNL/MTNL from spectrum liberalization and reforming.
 - (v) Justified sanction of funds from USO Fund to BSNL and MTNL and Immediate release of funds from USOF.
 - (vi) Immediate procurement of equipments and materials by BSNL and MTNL.
- (3) Pension of MTNL retirees to be paid by Government instead of MTNL as in the case of BSNL retirees.
- (4) Immediate issue of Presidential Directive from DoT for 78.2% IDA fixation for BSNL Employees.



In continuation of the earlier Trade Union Notice under reference above, it is hereby intimated that the BSNL and MTNL Executives and Non-Executives will organize two days Drama in all 2252 Circles/Corporate Office on the following demands:

- (1) All unabsorbed ITS officers should be forthwith relieved to DOT for true and just implementation of Absorption process OR All Employees, Absorbed/Recruited by BSNL & MTNL should be taken back to Govt service and permitted to work in BSNL and MTNL on deputation as in the case of unabsorbed ITS Group A officers.
- (2) Ensure financial viability of BSNL and MTNL by
 - (i) Immediate refund of BWA spectrum charges to BSNL & MTNL.
 - (ii) BSNL and MTNL should not be charged for the extra spectrum holding by them in excess of 4.4 MHz.
 - (iii) Adequate compensation for BSNL Rural Landline operations.
 - (iv) Exempt BSNL/MTNL from spectrum liberalization and returning.
 - (v) Justified sanction of funds from USO Fund to BSNL and MTNL and immediate release of funds from USO.
 - (vi) Immediate procurement of equipments and materials by BSNL and MTNL.
- (3) Pension of MTNL retirees to be paid by Government instead of MTNL as in the case of BSNL retirees.
- (4) Immediate issue of Presidential Directive from DoT for 78.2% IDA fixation for BSNL Employees.
