Sub: Filing of writ petitions by the Direct Recruit JTOs/JAOs against continuation of ITS Group 'A' officers in BSNL - any act of insubordination not to be tolerated - instructions regarding

Of late some of the Direct Recruit JTOs/JAOs have filed writ petitions in the Hon'ble Courts against the continuation of ITS Group 'A' officers in BSNL with the request to prevent such officers from functioning in their official capacities. Appropriate action has been initiated to suitably defend such cases. As regards period of deputation, no doubt DOT has extended the period of deemed deputation of Group 'A' officers upto 22.12.2008, matter has already been taken up with DOT for further extension of deputation period so as to avoid any unpleasant situation.

2. Posting of officers to various positions of organizational hierarchy is done by BSNL Corporate Office/field units in accordance with well-established rules of governance of organization and in discharge of due competence and authority. The prime objective & responsibility of the organization is to discharge its duties of providing telecom services to the general public and the posting of staff/officers and assignment of responsibilities are done so as to facilitate the same. Any act which comes in the way of discharge of these responsibilities, as mandated to BSNL by the Indian Government, has to be properly dealt with and countered. It is emphasized that without prejudice to the right of an employee to approach a court of law, absolutely nobody can be allowed to indulge in any act of insubordination, disobedience or disrespect for the authority in the guise of such petitions. It is requested that wide publicity may please be given to this and such incidences, if any, should be proceeded against in accordance with the BSNL CDA Rules, 2006.


