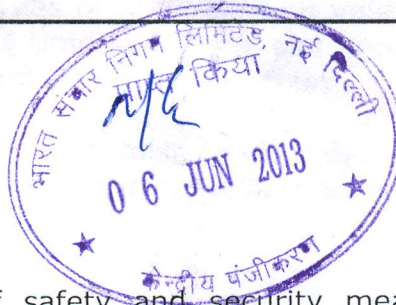

Subject: Regarding strengthening of safety and security measure of BSNL CO "Bharat Sanchar Bhawan"

Dear Sir,

It is learnt through the letter mentioned under reference issued by your good office that there was recently some security problem in the BSNL CO and hence some steps has been devised in order to strengthen safety and security measure. Although it is not mentioned, which kind of security problem have been experienced in recent past but it is really very serious matter, if it has happened and hence concern of the BSNL management is highly appreciable. **However, it is regret to mention that steps which has been mentioned in the above letter seems more to stop the entry of executives below DGM level in BSNL CO in the name of security problem which need to be reviewed immediately as we fail to understand how security of BSNL CO will be strengthened by stopping their own officers.** We are hereby submitting our following observations and suggestions in respect of letter mentioned under reference for your kind consideration.

1. Employees of BSNL working in any part of the country should not be treated at par with outside visitors and hence they should be allowed to enter in BSNL CO if they hold valid I-Card issued by BSNL by entering the detail in the register maintained by the reception officer.
2. There is position of work in BSNL CO from Asst. Manager onwards in the executive cadre; hence there is no reason to differentiate them in the name of below and above DGM just for entering into the corporate office. Visitors or known one came for meeting to below DGM shall not be left over to the mercy of DGM and above hence any visitors shall also be allowed on recommendation of AM and above. Moreover most of the DGM and above officers working in BSNL CO are either on deputation or deployment hence allowing visitors only on their recommendation is just like an encroachment on our own house by foreigners and it is their mercy to allow us or not to go inside. Such kind of perception in the mind of real executives of BSNL is not at all good for the health of the company.

3. All the association and union representatives must be issued permanent I-card/pass so that they could have free and easy access for pursuing the grievance of their members as and when required.
4. There should be fixed time slot for outside visitors including vender and contractor representatives except the employees of BSNL holding valid I-Card and they should not be allowed strictly beyond this time slot. Time slot should not be given beyond the office hour i.e. prior to 09:00 am and after 05:00 pm.

Sir, we hope that there is no security compromise by considering our above suggestions and hence it is requested to kindly consider the same and oblige.
