Subject: Addition of agenda point in the emergency CEC to be held on 7th and 8th

July-2013- calling impeachment against President and Organizing Secretary

AIGETOA CHQ owing to anti associational activity and continues unwarranted interference/overstepping in the working area of General Secretary.

Dear Representatives,

With the immense pain I am forced to call impeachment against President and organizing Secretary AIGETOA CHQ due to anti association activity and continue unwanted interference/over stepping in the working area of GS despite objection taken by GS at several platforms. Some of the facts detailed below:

- 1. Existing CHQ body was constituted in the AGM held in may-2010 at Faridabad. Since then both of them have not paid single rupees even their basic subscription to this association.
- 2. Both of them are working in Chennai telecom Circle but even AIGETOA Chennai Telecom Circle and Tamilnadu Telecom Circle has not paid single rupees to AIGETOA CHQ despite collection of subscription from members under direction and shelter of President and Organizing Secretary.
- Chennai telecom, Tamilnadu Telecom and Kerla Telecom Circles have not paid single rupees to CHQ quota since last election despite collection of subscription from members and they have expanded all the money themselves under supervision and shelter of President and Organizing Secretary AIGETOA CHQ.
- 4. Both of them are taking self decision in the working area of GS and provoking Circle Secretaries of some particular Circles to not pay their CHQ quota. More over they are deciding the action on cadre issues arranging fund directly from individual members with the help of some circles using this association platform in the name of cadre welfare and expending the same as per their own wish.
- 5. Both of them used to meet top management at BSNL CO and discuss the issues related to the members of the association without knowledge and information to General Secretary of this association despite continuous objection taken by GS.

Recently President along with Organizing Secretary visited in BSNL CO on 26–June-2013 without knowledge and information of General Secretary and submitted letter on letter paid of this association to Sr.G.M. (Pers) with copy to CMD and Director (HR) (Attached herewith) along with list of some of the CHQ/Circle office bearers and individual candidates (unverified) seeking retention/transfer in the posting of LDCE ignoring the fact that GS has already circulated the list of the members seeking transfer for verification by the Circle Secretaries in very transparent manner and working on that.
- 7. AGS Sh Amit Roy (signing authority on behalf of GS) was present in the BSNL CO on 26-06-2013 and met President but President did not share any information and directly submitted letter on letter pad of the association regarding transfer and immunity of some selected members in the posting of LDCE.

Dear representatives, one side some of the authorized representatives of AIGETOA are trying their best for welfare of the cadre putting their personal career on stack and other side they are trying to take the advantage of the platform and diluting the efforts bypassing all the constitutional provisions which is dangerous for survival of the association.

There are various pending issues of prime importance, resolution of which needs biggest movement and we have planned to give final shape in the coming emergency CEC to be held on 7^{th} and 8^{th} July-2013 but such activity of President and O.S. will surly take us nowhere.

It is not hidden that our biggest movement in the name of "Operation Sacrifice" held in Aug-2009 was concluded without expected outcome just because of unnecessary interference and overstepping of President and Organizing Secretary AIGETOA CHQ who met communication minister and given assurance to call off the strike without any prior information and consent of General Secretary.

I have objected several times at appropriate platform regarding unwanted interference and overstepping of President AIGETOA CHQ in the working area of General Secretary and house had given due consideration of the objection raised but situation is not improved. President and Organizing Secretary AIGETOA CHQ are trying to create double power centre in the association by assuming the unassigned authority which is totally unconstitutional and amount to be anti-associational activity.

In the light of the fact mentioned above It is not possible to run the affairs of the association smoothly at this crucial stage hence I am constraint to call impeachment against President and O.S. AIGETOA CHQ in the coming CEC to be held on 7^{th} and 8^{th} July-2013 at New Delhi.
