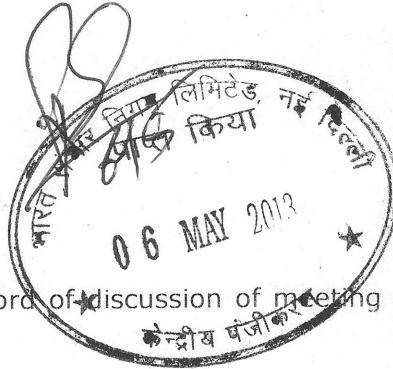

This association is highly thankful for issuing the record of the discussion of meeting held with Director (HR) on dated 22<sup>nd</sup> April-2013 vide letter mentioned under reference which will definitely help us to resolve the issues and enhance the mutual trust.

With due respect, we want to register of objection in content of the record of discussion for following points which needs to be corrected.

### **Point No. 2: Finalization of standard pay scale**

Management side agreed that the issue is pending since long and it needs to be finalized immediately. It was agreed that the committee constituted for the purpose shall submit its recommendation immediately; thereafter the decision shall be taken by the board. It was agreed that case shall be settled within one month. However, the order for E1+5 increments to JTO (SRD) is being issued.

### **Point no. 3- 30% superannuation benefit**

Chairman of the committee Sr. GM (Establishment) was present during discussion and conveyed that committee has already considered some % to be contributed from BSNL and employee both in respect of Direct Recruit towards superannuation benefit as recommended by DPE and he is going to put up the recommendation within 15 days before the management committee for final decision.



**Point No. 6- Recognition of AIGETOA**

Regarding parity of AIGETOA with SNEA and AIBSNLEA management side conveyed that SNEA/AIBSNLEA is recognized by DOT hence same facilities are extended in BSNL.
