### Subject: Intimation of expiry of AIGETOA CHO Body-Reg

### Respected Sir,

- 1. As per the guidelines issued on the functioning of service association in BSNL are mentioned in the circular no. 10-12/87-SRT dated 5th May 1987 issued by Ministry of Communication, DoT. I wish to write this D.O letter to inform you that the existing AIGETOA CHQ tenure has already expired in the month of May 2013 after its election in the year May 2010.
- The Last Central Executive Committee (CEC) of AIGETOA is elected 2. on an amended constitution; such amendment necessitated in the AIGETOA constitution to facilitate inclusion of other Executives of BSNL. But due to statutory lapses from our side the amended constitution was not registered with Registrar of Societies Haryana in stipulated time, nor duly notified by the Registrar of Society, Rewari,

RESULATION OF SOCIETIES ACT , 2012 HOLLIER AND CAME THE FORCE ON 28.03.2012.

Your are hereby requested not to entertain any office bearers from the old body since the tenure is already expired. In addition, I regret to inform you that Shri. R P Shahu was suspended from the AIGETOA for his anti association activities for breach of Clause 7 of our Constitution by issuing an impeachment notice to the undersigned without any provisions in the constitution of AIGETOA. And also non submission of

Haryana. Legally, the original constitution only prevails over the unregistered constitution and previous body has no legal sanctity to carry out any affairs of the society. In case, if the last CEC body does any act then it is unconstitutional as per the law. Being a President of the Society on two succeeding tenures I take this liberty to write on behalf of the society for smooth functioning and effective representation of the the society.

- 3. As per article 8 the Constitution of AIGETOA any elected body either in CHQ or Circle will have maximum 3 years and does not have any provision for extensions, Interim or adhoc body. Only option is to elect the office bearers by conducting all India conference through the franchise of the mandate from newly elected collegiums as per the provision of the section 32 of "The Haryana Registration And Regulation Of Societies Act", 2012 notified and came into force on 28.03.2012.
- 4. Your are hereby requested not to entertain any office bearers from the old body since the tenure is already expired. In addition, I regret to inform you that Shri. R P Shahu was suspended from the AIGETOA for his anti association activities for breach of Clause 7 of our Constitution by issuing an impeachment notice to the undersigned without any provisions in the constitution of AIGETOA. And also non submission of the proper accounts statements and audited records to the Registrar of Society as well as to the BSNL and Other offences involving moral turpitude. (Suspension Letter Enclosed)
- 5. In case, entertaining any representations from the Previous CHQ body elected as per the amended constitution ultra vires the provisions of the Law and Rules cited in the above referred letters. You are respectfully requested not to entertain any communication from Shri. R P Shahu in the form of notice, letters, interview etc either orally or in written form until the AGM.

- 6. In addition, it is requested to depute suitable officers from the BSNL corporate office to function as a election observer to ascertain the fair conduction of the election process of collegiums as per section 29, 30, 31, 32 of the "The Haryana Registration And Regulation Of Societies Act, 2012" notified and came into force on 28.03.2012. And also issue necessary instructions to the undersigned regarding the legal provisions as well as guidelines of the BSNL in this regard.
- 7. In future, only the duly elected body of the AIGETOA as per the provision of the Constitution of AIGETOA may be permitted interact with management after receiving due certification from the Registrar of the Society, Rewari, Haryana clearly endorsing the governing council of AIGETOA CHQ.



- 4. Aims & Objectives: The object for which the society is established are:

#### 5. Conditions:

The income and property of the society shall be applied solely towards the promotion of the objects of the society as set forth in the memorandum of association and no portion thereof shall be paid or transferred directly or indirectly to the member of society.

No member of the society shall be appointed to any salaried office of the 2. society, or any office of the society paid by fees, that no remuneration shall be given by the society to any member except repayment of out of pocket expenses and interest on money lent or rent for premises to the society.

The society by its constitution is required to apply its profit if any, or other 3.

income in promoting its objects.

If upon the winding up or dissolution of the society there remain after 4. satisfaction of all its debts and liabilities any property what so ever, the same shall not be paid to or distributed among the member of the society but shall be given or transferred to some other institution having objects similar to the objects of the society to be determined by the member of the society at or before the time of resolution.
