**Sub:** Reply of your letter (No. BSNL/31-4/SR/2013 Dated 11-07-2013) on the subject "office bearers of AIGETOA-election thereof regarding"

**Dear Sir,**

The undersigned has received a letter under your signature vide letter No. mention in above subject seeking clarification regarding election term and validity of office bearers of this association in response to complain filed by Mr. N.J.P. Shilohu Rao, now Ex-President of this Association.

At the outset I want to bring to your kind notice that Mr. N.J.P. Shilohu Rao has been removed from the post of the President with 100% vote of the collegiums approving his said removal in meeting of CHQ and circle delegates held on 7<sup>th</sup> and 8<sup>th</sup> July-2013 at New Delhi. Intimation in this regard along with updated list of CHQ office bearers has already been submitted to your good office on 9<sup>th</sup> July-2013 vide letter **No: CHQ/AIGETOA/429 dated 9<sup>th</sup> July-2013.**

In reference to your letter cited under subject regarding adhering provision of by-laws/constitution, holding of annual conferences, term of election and validity of CHQ office bearers of this association, the following reply is submitted: -

1. This association is registered at S.N.-72 under section-21 of Societies Registration Act, 1860 at Registrar Office Rewari, Haryana having approved memorandum and constitution (copy of the same is attached herewith).
2. Our last election of office bearers of CHQ was done in AGM held on 8<sup>th</sup> and 9<sup>th</sup> May-2010 at Faridabad, Haryana with due notification and under presence of CMD, BSNL as chief guest and other Sr. officers from BSNL.
3. As per the constitution of AIGETOA, this association can held meetings/conferences like Central Executives Committee meetings, General Meeting, Ordinary General Meeting, Special General Meeting etc with due notification.
4. While other meetings are general in nature and on need basis but Annual General Meeting (AGM) is statutory in which collegiums from circles participates. As per the provision of Article-19 of the AIGETOA's constitution, the society shall hold an Annual General Meeting every year and not more than 15 months shall elapse between two successive AGM.
5. As per the Article-8 of the AIGETOA's constitution, all members of the Executives Committee shall retire at the Annual General Meeting every three years following their election when the new executives committee shall be formed.

6. After election of CHQ office bearers on 9<sup>th</sup> May 2010 first AGM was held on 6<sup>th</sup> and 7<sup>th</sup> Feb-2011 at Kolkata with due notification and intimation to your good office vide letter **No: CHQ/AIGETOA/310 Dated 12/01/2011** and in presence of Sh K.C.G.K Pillai, current Director (Finance) of BSNL as chief guest. The copy of resolution passed at meeting was also submitted to your good office vide letter **No: CHQ/AIGETOA/315 dated 18<sup>th</sup> March-2011.**
7. Second AGM was held on dated 16<sup>th</sup> and 17<sup>th</sup> June-2012 at Bangalore with due notification and intimation to your good office vide **No: CHQ/AIGETOA/356 dated 29<sup>th</sup> May 2012** in presence of Sh. A.N. Rai current Director (Enterprises and HR) as chief guest. The copy of Resolution passed at meeting was also submitted to your good office vide letter **No: CHQ/AIGETOA/465 dated 17<sup>th</sup> July-2012.**
8. This association has held the meeting of collegiums who are eligible and authorized to elect CHQ office bearers on dated 21<sup>st</sup> and 22<sup>nd</sup> April-2013 (before 3 years of last election) at New Delhi with due notification vide letter **No: CHQ/AIGETOA/403 dated 15<sup>th</sup> March-2013** and with clear agenda of deciding election norms and date and venue for next AGM where election of new office bearers has to take place.
9. Article-8 of the constitution states that all members of executives committee shall retire every three years but only at AGM following their election when the new executives committee shall be formed and Article-19 of AIGETOA's constitution states that AGM can be held once in 15<sup>th</sup> month. On proposal of then President Sh. N.J.P. Shiloh Rao (complainant herein) himself, Article-8 read with article-19 of the constitution, collegiums of the circle who elects the CHQ office bearers have resolved in the meeting held on 21<sup>st</sup> and 22<sup>nd</sup> April-2013 i.e. before three years of the last election to give extension to the CHQ office bearers till next AGM proposed to be held on 14<sup>th</sup> and 15<sup>th</sup> Sep-2013 which is within the range of 15<sup>th</sup> months since last AGM as per the provision of constitution where election of new office bearers is proposed.
10. This association is strictly adhering all the rules and regulation of the society without any fail despite your good office has not extended minimum facilities like special leave to the office bearers of this association on our multiple and consistent request for many years with the reason best known to your benign authority. Your kindness is also requested to supply to undersigned the consolidated guidelines of BSNL if any regarding executives association in BSNL so that this association can ensure the compliance thereof.
11. Kindly refer the letter of complainant Mr. N.J.P. Shiloh Rao, wherein, one side he says that terms of the CHQ office bearers is expired and existing body has no more validity to represent the issues of members of AIGETOA, and other side he is writing this complain in the capacity of President using the letter pad of the association. As per the constitution of AIGETOA, President post is also an elected post and Mr. N.J.P. Shiloh Rao was elected as President in the same AGM wherein other office bearers including undersigned were elected. He has also cited that undersigned has been suspended from the post of General Secretary by him hence requested not to entertain but did not mention about the resolution of collegiums. As per Article-23 the constitution of AIGETOA President has no power to suspend any governing body of AIGETOA without consultation of executives committee. Moreover he has made copy to the M/s Axis Bank to stop the transaction of the association bank account. **All this shows that complainant Mr N.J.P Shilohu Rao has acted in a manner with bad and malaise intension and willfully trying to mislead the management and to sabotage the functioning of this association. Addressing misleading letter to top of this company including CMD and Director (HR) with wrong**

**statement/information and trying to sabotage the functioning of this association hence representation of the members, which attract immediate action as per BSNL CDA rule. Without prejudice to the right of this association to seek legal action against the complainant, you are kindly requested to take appropriate action in this regard against the complainant Sh. N.J.P Shiloh Rao.**

12. Lastly, it brought to your good notice that the law of societies in the state of Haryana, where AIGETOA is registered, is administered by the Registrar of Societies Haryana. So, in the instant case, if at all any lapse is alleged, the Registrar of Societies Haryana is alone competent to take the cognizance thereof. Hence, BSNL is requested to desist from the initiation of any action or inaction on the said complaint of Mr. N.J.P. Shiloh Rao, which otherwise de hors the statute.
13. **On behalf of this Association, undersign is however ready to submit all the relevant documents in support of my above statements as and when required.**
