Subject: Extension of the term of Circle Body of AIGETOA Rajasthan expiring on 01.09.2022 -Reg.

AIGETOA Central Governing Body is in receipt of the request from Rajasthan CEC to give extension of six months to the current Circle Governing Body, which is expiring on 01.09.2022, on account of the reasons enumerated in the referred letter.

After detailed deliberations, AIGETOA Central Governing Body arrived on the conclusion to grant extension of tenure to the Circle body of AIGETOA Rajasthan for Three Months i.e. from 01.09.2022 to 30.11.2022 in view of the recommendation of the Circle governing body and for completion of the formalities of election of new circle governing body. Accordingly, extension is granted w.e.f 01.09.2022 to 30.11.2022 to the AIGETOA Rajasthan Circle body to complete all the process and to carry forward activities of the association in the period, as per the resolution passed by the AIGETOA CHQ.

Therefore, the current Circle Body of AIGETOA Rajasthan will continue to look after the charge of the association for another period from 01.09.2022 to 30.11.2022 or till election of next Circle Governing Body, whichever is earlier. The Circle Secretary, AIGETOA Rajasthan is requested to complete the process of Circle Collegiums' Election and formalities of Election of New Circle Governing Body in the stipulated time as per the laid down provisions in constitution of AIGETOA. Further, all concerned are requested to continue the due facilities and privilege to the Circle body of AIGETOA Rajasthan in the extended period i.e. up to 30.11.2022 or till election of the new body, whichever is earlier.
