BSNL Sports and Cultural Board were constituted for 2021-23 after a long gap to revive the sports and cultural activities in BSNL, which has taken back seat since long time due to one reason or other. These activities were a major contributor towards brand visibility of the organisation as well as due recognition of the sports personalities of the department. Earlier due to financial crunch and later due to worldwide pandemic of Covid, no sports activities was carried since last 3 years. As the pandemic has subsided and life has returned to the normal old days, it is high time to restore the glory of Sports and Cultural activities in BSNL once again.

The New Sports and Cultural Board for 2021-23 were constituted and hardly six months are remaining of the two year period but we failed to convene even single meeting of the board. This shows our lack of interest towards the sports and cultural activities in the organization and so the situation should improve. The Sports and Cultural Board must meet immediately to realize its objective by approving the Sports calendar and conduct 19th All India BSNL Sports/Cultural Tournament without further delay. We have submitted our views also on some important aspects related to it through referred letter #1 to consider for improvement.

Accordingly, we request your good self to direct the concerned unit to call the very first meeting of BSNL Sports and Cultural Board 2021-23 immediately to transact the import business for approving the calendar and reviving the sports activities in the ongoing financial year 2022-23.
