Subject: Harassment of our District Secretary Ludhiana BA, Punjab Circle by the BA Head, Ludhiana-Reg.

Respected Sir,

This is to bring to your kind notice that no visible measure has been initiated to address our complaint about victimization of the office bearer of the association despite bringing it to your esteemed knowledge. We have shown our serious concern on the immunity letter issued by the SR Cell vide number BSNL/20-22/SR/2022 dated 14.10.2022 and warned that BSNL Corporate Office is providing a tool in filed units to harass and use high handiness to suppress the genuine voice of the representatives.

Shri Jaspreet Singh, District Secretary AIGETOA Ludhiana BA was transferred on 18.10.2022 vide letter under Ref #5 without following any stipulated norms by the BA Head Ludhiana. Then he was relieved for the new station very next day i.e. 19.10.2022 vide letter under Ref #4 in a hurriedly and biased manner. The matter was brought in the notice of the CGM Punjab also for intervention and protection. The complaint lodged by out Circle Secretary Punjab is also enclosed for ready reference.

It is further submitted that due to his health issue, his medical leave applied from 20-10-2022 to 22-10-2022, was not accepted by his controlling officer vide letter Ld/DE/Staff/2022-23/ dated at Ludhiana 22.10.2022 by instructing to resubmit a new medical certificate through Civil Surgeon for the period, which itself reflect the targeted harassment of the officer. This is not an isolated case but previously also we have reported our complaint about high handiness by the BA Head Ludhiana in other matters and atmosphere of fear and stress prevailing in the BA due to selective target and biased attitude by the unit head.

In the light of above, we request for your kind and urgent intervention in the matter and reinstatement of our District Secretary on his previous position. We demand for recall of the present BA Head to bring focus on the growth and development of the BSNL at Ludhiana BA. We further request for a suitable direction to CMG Punjab to ensure sanctity and get rid of the office of the BA Head from prejudice and party politics.
