Sub: Issuing the supplementary promotion orders of candidates affected by SDE-2007 reversal issue by one time resolution of the issue as assured to this association from time to time at various platforms-regarding.

Dear Sir,

This is to bring to your kind notice that the people who belong to SDE 2007 reversal issue and despite completing the eligibility criteria as per clause 12(5) of SDE RR 2002, were not included in the promotion list of SDE to AGM issued by BSNL CO on dated 16.11.2022. Many a time's, management assured AIGETOA, the Majority Association to resolve this issue as a onetime measure in various meetings including the recorded agenda meetings, but still their names could not find place in the final seniority list.

It is beyond doubt that candidates were never at fault and the whole complexity has arisen due to lacunae on the part of persons dealing with the issue and section never had clearly stated anything in clear and non-ambiguous terms to circles with regard to their eligibility. It is again to reiterate that these 2001 batch JTOs who became SDEs via LCDE 2007 were fully eligible as per the prevailing SDE RR 2002 and the clarificatory order issued by BSNL CO on dated 16.04.2007 vide its letter number 2-29/2005-Pers II dated 16.04.2007 against the queries raised by the various Telecom Circles with respect to eligibility criteria to appear in the LCDE 2007 competitive Exam. During all discussions, it has been proved beyond doubt by our association that these candidates were fully eligible to appear in the exam and hence their seniority should be kept intact. Pending court cases if any can easily be sorted out through amicable discussions with applicants as stated in the minutes of meeting dated 9th February 2022 with this association.

It is understood that the name of these candidates were present in the Seniority Lists and vacancies have been kept aside but their names could not find its way to the final promotion list issued dated 16.11.2022. Hence we request your good self to kindly direct the concerned unit to settle the issue and urgently release the promotion orders of these left out candidates also to avoid perpetual loss of their seniority.
