Subject: Calling off the Lunch Hour Demonstration on the appeal of BSNL Management.

This is in reference to the lunch hour demonstration notice served vide our letter dated 24.01.2024 and appeal from management vide SR cell letter no. BSNL/7-1/SR/2023 dated 2nd February 2024 issued subsequent to the detailed meeting with management and AIGETOA under the chairmanship of Hon'ble Director HR BSNL. It was assured in the meeting that positive and firm action shall be taken by management on the charter of demands raised by AIGETOA.

Thereafter, on the intervention of corporate management, a meeting was held on 03/02/2024 between GMTD Ghaziabad, representatives of UP West Circle Administration and representatives of AIGETOA in the O/o GMTD Ghaziabad for resolution of one of the issue raised in the organizational action notice. In the bilateral discussion, the issue was discussed in detail and was resolved to the satisfaction of both the sides. (Minutes of the meeting attached). We are extremely thankful to the management for timely intervention and appropriate steps for resolution of the issue. We hope that such type of timely and prompt action by management on issues will help maintaining industrial peace in the larger context.

As assured, the other issue pertaining to sufficient resources for the executives working in BSNL shall be discussed in detail in the agenda meeting dated 09.02.2024. We anticipate a positive consideration of the issues raised (Reimbursement/ Enhancement of Laptop, Mobile, TA/DA/Accommodation rates etc.) in the aforesaid agenda meeting.

In view of the firm and timely action by management as above, the lunch hour demonstration notice is hereby called off.
