**Election Process and Schedule:-**



2. Online nominations for post of (CP / CS / CFS / 6ACs / 2CVPs) will be invited through website /link / /Google Form for new governing body from 16/03/2024 to 22/03/2024. Any valid AIGETOA member of Haryana Circle can file the nominations for any post.

5. After verification, Final list of nominations received will be displayed on dated 27.03.2024 at website/link [www.aigetoachq.org](http://www.aigetoachq.org).
6. Sequence of election will be decided by Returning Officer in consultation with Circle Collegium and decision of returning officer will be final in this context.
7. Any person from the final list of nominations received can contest for any post in the governing body as per constitution of AIGETOA, provided he/she is not elected till that time for any other post.
8. Voting for election of Circle Office Bearers will be done by the electoral collegium as per provision of constitution of AIGETOA. As per the constitution, the collegium members eligible to vote will be allowed to cast their vote in person and no proxy voting shall be allowed.
9. Any objection on the list of collegium of the society entitled to vote or members to be elected as governing body of AIGETOA Haryana shall be decided by the returning officer in consultation with the office bearers of the society. However the decision of the returning officer shall be final in the event of any difference of opinion.
