Sub: Request to settle the grievances and concerns raised by LICE candidates regarding Question Paper and to expediting the process for declaration of results and promotions thereof -reg.

## Respected Sir,

We would like to attract your kind attention on the above cited subject. The Limited Internal competitive Examination took place for JTO and SDE cadre for SDE and AGM promotions respectively. We are in receipt of many queries and feedback from the candidates who appeared in the LICE held on 16<sup>th</sup> and 17<sup>th</sup> April 2024. We hereby submit the following concerns raised by various candidates and the remedy proposed:

- 1. Many Questions had not been framed properly and some questions did not have correct Answers. Some questions had more than one answers: we request that:
  - A) Wrong Questions/ Question with wrong Answer must be discarded and total should be reduced OR Marks should be given to all (even if attended or Not, because wrong answer lead some candidates not to attend the question due to negative marking).
  - B) Questions having more than one probable Answer Marks should be given to all candidates.
- 2. Answer Key of the paper must be displayed immediately along with attempted question paper to the login of candidate's portal as mentioned in process.
- 3. As it is an internal departmental Examination, There should not be any objection fee for correction of Answer / question. It must be free of cost AND associations (Majority and Support) should be allowed to put the objections of question on behalf of candidates.

- 4. We earlier requested to expedite the process with maximum available vacancies, as methodology discussed many times total number of vacancies must be raised and LICE Quota should be enhanced as one time measure.
- 5. The process of displaying result, calling objection, revised key along with result declaration should be done before 30<sup>th</sup> April 2024, So that promotion order can be issued soon.

We sincerely hope your kind intervention will expedite the issue and genuine concern will be taken care by Recruitment and Personal sections.
