Sub: The Case of Felling of 400+ Trees in BSNL Exchange Campuses including Teak wood & sandal wood; Victimization of the District Secretary of Dharmapuri OA, Tamilnadu Circle for Exposing Conspiracy and Revenue Loss - reg.

Respected Madam,

Please find attached herewith letter from AIGETOA Tamilnadu Chapter wherein a serious issue pertaining to a revenue loss amounting to approximately 25 Lakhs to BSNL has been highlighted. The incidence of felling of over 400 trees, including valuable teakwood and sandalwood, within the BSNL Exchange campuses at Dharmapuri OA, has been brought to light by the District Secretary of AIGETOA.

Representations regarding this matter were submitted by the Circle Secretary of AIGETOA Tamilnadu to the then CGM on 26/04/2024 and 15/05/2024, requesting a suitable inquiry into the activities. These representations are enclosed herewith for your kind reference.

Unfortunately, instead of addressing this grave issue, the BA Administration has initiated departmental proceedings against the District Secretary of AIGETOA Dharmpuri OA, who courageously exposed this significant revenue loss to BSNL. This act of victimization appears to be a clear attempt to suppress the genuine voice of the Association.

The suppression of Association representatives' voices not only undermines their efforts to maintain transparency but also endangers the integrity of the BA Administration. It is paramount to address such issues to ensure a fair and transparent administration within BSNL.

We, therefore, request you to initiate a thorough inquiry into this matter and take appropriate actions to safeguard the interests of BSNL and its employees. Ensuring a

level playing field for the recognized Association is essential for fostering a transparent and corruption-free environment within the organization.

We trust this matter will be considered with the seriousness it deserves to take prompt action to ensure that the corruptive officers at any level will be punished so as to safeguard the assets and revenue of BSNL.

The Chief General Manager (Telecom), Tamilnadu Circle, BSNL, Chennai – 600 006. Respected Sir,

Subject: Request for detailed unbiased inquiry -reg.

From February 2024 onwards, 200 trees including Eucalyptus, teak wood, and one sandalwood from Ulagam Exchange, Sipcot I Exchange, Sipcot II Exchange, Hosur main Exchange and Hosur town RSU Exchange valued more than 25 lakhs, were illegally felled by Shri Sekar AGM, with unauthorized approval from Shri Prabhudorai DGM and GM Salem. Smt. CP Subha, GM Salem, is also implicated in this unlawful activity, as revealed by President Ulagam Village. A police complaint has been lodged by a CPI political party representative against the BSNL Administration. It is learnt that a public Agitation is also planned by CPI party under the president-ship of Thally MLA shri Ramachandiran.

It is also learnt that the President, Ulagam Village and Political parties have taken up this matter to the attention of the District Collector, Krishnagiri. The District Forest Officer has conducted inspections at the exchange sites on 24/04/2024 where the theft occurred, with a report forthcoming. There was a planned fire incident by the culprit to hide the value of theft which was reported in the newspaper on 18th April 2024, itself. But, as usual the DGM/AGM are trying to punish the junior most executives (JTOs) in this matter to safeguard themselves. Hence, it is urged that an impartial investigation be conducted into this matter, refraining from prejudice against Smt. Subha GM, Shri Prabhudorai, DGM and Shri Sekar, AGM.

ஒசூர், ஏப்.18: ஓசூர் பிஎஸ் என்எல் அலுவலக வளா கத்தில் பற்றி எரிந்த தீயின் புகை, வானுயர பரவி கடும் புகைமூட்டம் எழுந்ததால் பரபரப்பு ஏற்பட்டது.

ஓ சூர் அரசு மருத் துவமனை அருகே பிஎஸ் என்எல் அலுவலக கட் டிடங்கள் உள்ளது. இந்த அலுவலக வளாகத்தில் இருந்த ஏராளமான மரங்களை வெட்டிய பிஎஸ்என்எல் நிர்வாகத் தினர், காய்ந்த சருகுகள் மற்றும் விறகுகளை அங்கு குவித்து வைத்திருந்தனர். இந்நிலையில் நேற்று, ஊழி யர்கள் சிலர் வளாகத்தில் இருந்த காய்ந்த சருகுகளை தீவைத்து எரித்துள்ளனர். அப்போது தீ கொளுந்து விட்டு எரிந்ததால், தீயை அணைக்க முடியாமல் ஊழியர்கள் திணறினர். தீ

மேலும் பற்றி எரிந்ததால் அப்பகுதி முழுவதும் கடும் புகைமூட்டம் ஏற்பட்டது. வானுயரத்திற்கு ஏற்பட்ட புகைமூட்டத்தால் அப்பகு தியில் பரபரப்பு நிலவியது. அருகிலேயே அரசு மருத் துவமனை, குடியிருப்பு பகு திகள் இருந்ததால் பொது மக்கள் அச்சம்

அடைந்தனர். இதனை பார்த்த அப்பகுதி மக்கள் உடனடியாக ஒசூர் தீய ணைப்பு துறையினருக்கு தகவல் தெரிவித்தனர். அதன்ப்பேரில் சம்பவ இடத்திற்கு சென்ற தீய ணைப்பு வீரர்கள் தண் ணீரை பீய்ச்சி அடித்து தீயை அணைத்து கட்டுக் குள் கொண்டு வந்தனர். இதுகுறித்து அறிந்தபிஎஸ் என் எல் அதி காரி கள் அங்கு வந்து சம்பவத்தை கேட்டறிந்து. சருகுகளை தீ வைத்து எரித்த ஊழியர்களை கண்டித்தனர். வானுயர பரவிய புகை மூட்டத்தால் பரபரப்பு ஏற்பட்டது.

Please refer to our earlier letter dated 26/04/2024, in which we expressed our concern that the BA administration is unjustly targeting innocent JTOs regarding the unlawful removal of trees at various exchange premises in and around Hosur. We had expected your prompt intervention and initiation of a vigilance complaint on this matter. Unfortunately, it is felt that no action has been taken by the Office of the CGM TN.

Therefore, we once again request a suitable vigilance inquiry to investigate the involvement of GM Salem in the illegal removal of highly valuable sandalwood and teak trees from the Telephone Exchanges.

Enclosed is the note sheet approval used by Shri Sekar, AGM, to release the lorry from the custody of the President of Ulagam Village during the unlawful removal of these valuable trees. The note sheet approval itself provides sufficient grounds for disciplinary action against GM Salem.

- 1. How can it be claimed that the trees did not have commercial value?
- 2. How can the GM approve the cutting of trees without any inspection by the Civil or Planning Wing?
- 3. Why is there no official order from the Planning Wing permitting the execution of this work?
- 4. Why did the GM approve the note sheet proposal for tree cutting when it was not initiated by the Exchange in-charges?

- 5. When the GM knew that the note sheet was initiated by the AGM himself without the knowledge of the field in-charge, why is the GM now insisting on taking action against the JTOs?
- 6. When the JTOs questioned the tree cutting work executed by Shri Sekar, AGM, the AGM responded that the work was being executed with the GM's approval and instructed the JTOs to focus on 4G-related work.
- 7. It is evident that AGM Shri Sekar misused his official capacity and authority to exclude his subordinate JTOs to hide this illegal tree removal. How can the JTOs be held responsible for this unlawful activity?
- 8. There was no police complaint lodged by the BA administration regarding the removal of trees from five exchange premises, till date.
- 9. Moreover, the GM herself admitted at a police station that the contractor engaged for the tree cutting is a relative of hers.
- 10. This raises the question, what procedures were followed to engage this contractor for the removal of valuable trees, scrap items and A/C units?
- 11. An analysis of the GM's six-month Call Details Records may reveal a conspiracy behind the illegal removal of valuable trees, scrap materials, and A/C units from the exchange premises by Smt Subha GM, Salem, Shri Sekar AGM, and a contractor, Shri Venkatesan.

We expect a fair and just inquiry on this looting of valuable things from Exchange premises at the earliest please and take suitable disciplinary action on GM Salem, DGM Dharmapuri & AGM Hosur.
