I am enclosing here with a representation received from **Shri Ravi Shil Verma, General Secretary, All India Graduate Engineers & Telecom Officers Association, which is a recognised association of executives of BSNL and is affiliated under the umbrella of Bhartiya Mazdoor Sangh.** I have gone through their representation and feel that the issues are genuine in nature and deserve a sympathetic consideration.

The employees and executives of BSNL have been doing a great job in the service of the nation and they have always stood firmly for Bharat and its people in the most difficult circumstances, the very recent example being the provisioning of uninterrupted mobile services at Landslide hit area of Wayanad. Further BSNL's employees role is very crucial in achieving the ambitious mission of Swadeshi 4G/5G wherein executives and employees of BSNL have been giving their best efforts to realise the dream of Aatma Nirbhar Bharat in Telecom.

I sincerely feel that the executives and employees of BSNL deserve resolution of their long pending HR issues related to (i) **implementation of 3rd PRC in BSNL by Waiving off the affordability clause. BSNL employees are still on 2007 pay scales, and the 3rd PRC has been pending since 2017. Despite this, BSNL has shown EBITDA positivity for the last three financial years;** (ii) **Standard Pay Scales of E2 for JTO/JAO and E3 for SDE/AO which is pending to be resolved since 01.01.2007;** (iii) **Extending Promotional Avenues in a time-bound manner by diverting quotas, which has no financial implications;** (iv) **Implementation of 30% Superannuation Benefits for Direct Recruits of BSNL, pending since 01.01.2007;** & (v) **Revision of TA/DA and Other Allowances to match current market conditions, as BSNL is still forcing it's employees to discharge the official outstation duties on 1996 rates which were part of the 5th Pay Commission implementation.**

Therefore, I request your intervention in settling those issues. I also request you to grant them an appointment for a detailed meeting on issues related to BSNL Revival and resolution of their long pending HR issues.
