Subject: Collective Condemnation of Functioning and Request for Change in Leadership of TN and CHTD - regarding.

Respected Sir,

We, the undersigned Unions and Associations, express our grave concern and strong condemnation of functioning of Chief General Manager, Tamil Nadu Circle and Chennai Telephones. Since assuming charge, his approach has caused severe demoralization among employees, deterioration of services, and risk to BSNL's reputation and revenue.

1. Denial of Democratic Engagement

Repeated refusal to meet Unions and Associations under the pretext of workload reflects disregard for participatory governance.

2. Failure in HR & Employee Welfare

- HR issues, including urgent medical advances, remain unresolved due to inaction.
- Transfers in Tamil Nadu are being issued without following norms.
- Punitive actions such as increment cuts against Association office-bearers in CHTD are vindictive and unacceptable.

It is also requested to withdraw all the punishment orders given to office bearers of CHTD.

3. Decline in Services & Revenue Risk

- 4G service quality is deteriorating daily, with no corrective review.
- Due to inaction, key clients like Tamil Nadu and Chennai Police have threatened CUG surrenders, risking ₹4 crore monthly revenue.
- Instead of service improvement, unnecessary hurdles are being created.

4. Adverse Attitude & Lack of Leadership

- CGM's functioning reflects an adamant and authoritarian attitude, treating BSNL as a personal domain rather than a public sector entity.
- Despite CMD and Director (HR) interventions, there has been no improvement.
- Lack of experience in HR and field operations has further aggravated the situation.

This continued approach is detrimental to employee morale, customer confidence, and BSNL's growth in Tamil Nadu and Chennai.

Therefore, all Unions and Associations jointly demand immediate replacement and appointment of a competent CGM with proven experience and commitment to employee welfare and service development.

As a mark of protest against this adamant attitude and administrative failure, a lunch-hour demonstration will be held on 6th October 2025 at the CGM office and all BA/OA HQs of Tamil Nadu and CHTD.
