Subject: Strong objection to calling volunteers for posting at Telecom Training Centres including RTTC Jaipur without exhausting the existing approved panel – reg.

Respected Sir,

This is in reference to CGMT ALTTC Office Letter No. **SE-10/132/volunteer/2025/34 dated 19.12.2025**, inviting volunteers for posting of SDEs/Executives at various Telecom Training Centres.

On behalf of AIGETOA, we place on record our strong objection and serious concern regarding the re-initiation of the volunteer process for certain centres, particularly RTTC Jaipur, despite the availability of an already finalized, approved, and valid selection panel.

In this context, your kind attention is invited to **e-File No. ALTTC-ALT/HR(13)/4/2024-HR dated 18.06.2024**, circulated to all CGMs, BSNL Circles, on the subject "Volunteer posting at RTTC Jaipur under ALTTC Circle – Declaration of Result (Online Assessment + Interview)", which refers to Office **Order No. ALTTC-ALT/HR(30)/1/2024-GM(HQ) ALTTC/1/649868/2024 dated 16.04.2024.** Through the said order, volunteers were duly selected for posting at RTTC Jaipur under ALTTC Circle in the cadres of AGM(T)/AGM(E)/AGM(C)/SDE(T)/SDE(E)/SDE(C)/AO.

The above selection was conducted through a rigorous, transparent, and merit-based process involving Phase-I and Phase-II online assessments, followed by interviews and presentations. A **merit-wise panel (Annexure-A)** was issued after due approval by the competent authority. The entire exercise consumed substantial organisational time, effort, and resources.

In this background, the decision to once again invite volunteers and propose a similar selection process for RTTC Jaipur is <u>unwarranted and completely avoidable</u>. Repeating the same exercise without exhausting the existing approved panel not only undermines the sanctity of the earlier selection but also causes avoidable uncertainty and demotivation among the already empanelled executives. Such actions further give rise to serious apprehensions regarding the intent behind initiating a fresh process, particularly when the earlier panel remains valid and unutilised.

AIGETOA has already brought to the notice of BSNL Corporate Office and the Personnel Section our objections regarding arbitrary transfer and posting orders issued by ALTTC Circle. However, no corrective action has been taken so far.

In view of the above, AIGETOA firmly demands that:

- Executives already selected and empanelled for RTTC Jaipur through the approved process **must be given first priority** for posting.
- Postings to RTTC Jaipur and other Telecom Training Centres <u>should be made strictly</u> <u>from the existing approved panels</u>, wherever applicable, instead of conducting identical selection exercises again.
- No fresh volunteer or selection process should be initiated without fully exhausting the earlier approved panels.
- The Personnel Section and Establishment Section of BSNL Corporate Office may be directed to scrutinise the transfer, posting, and retention orders issued by ALTTC Circle and ensure necessary corrective action in line with notified policies.

We sincerely hope that the management will act in the spirit of fairness, transparency, and administrative prudence, and issue necessary instructions at the earliest for utilisation of the existing approved panels. We trust that this genuine concern of the Association will receive your immediate and positive consideration. Failure to address the issue may compel the Association to pursue the matter further at appropriate forums.
