**Sub: Online Transfer Portal (OTP)- Opening of window for annual inter circle transfers for the year 2026-regarding.**

The window for online submission of transfer application for annual inter circle transfers for the year 2026 is going to be opened w.e.f. 1st January 2026 to 15th January 2026.

2. On the basis of working strength of Accounts Officers, BSNL circles/units are categorized broadly in three categories as detailed below for the purpose of inter- circle transfers:-

Deficit Circles	Chhattisgarh, Haryana, Rajasthan, Maharashtra, Jammu & Kashmir, Karnataka, UP (W), Uttarakhand, Gujarat, Madhya Pradesh, A&N, UP(East), Tamil Nadu, Andhra Pradesh.
Surplus Circles	Telangana, Himachal Pradesh, Jharkhand, Bihar, North East – I, Odisha, West Bengal, Core Network (Tx-North), Punjab, Kerala, Sikkim, Core Network (Tx-North East), Chennai Metro District, Inspections & QA, ITPC, Calcutta Metro District, Core Network(Tx-East).
Just Sufficient Circles	Core Network (Tx-South), North East – II, Assam, ALTTC, BBNW, Core Network (Tx-West), Corporate Office, NFS.

3. The executives are requested to submit three choices of circles, preferably for deficit circles, so that transfer request may be considered for their choice circle, subject to the administrative constraint.

4. The executives may also withdraw the pending applications of previous OTP window, if any and may apply afresh as per instructions already issued.
